

SENATE COMMITTEE OF REFERENCE AMENDMENT
Committee on Finance.

SB19-138 be amended as follows:

- 1 Amend printed bill, page 3, line 20, strike "(1)" and substitute "(1); and
- 2 **add (3)".**
- 3 Page 3, line 21, strike "(a) A" and substitute "A".
- 4 Page 3, strike lines 22 through 27 and substitute "contractor who is
5 awarded a contract for more than fifty thousand dollars for the
6 construction, erection, repair, maintenance, or improvement of any
7 building, road, bridge, viaduct, tunnel, excavation, or other public works
8 for any county, city and county, municipality, school district, or other
9 political subdivision of the state, and a contractor who is awarded a
10 contract for more than one hundred fifty thousand dollars for the
11 construction, erection, repair, maintenance, or improvement of any
12 building, road, bridge, viaduct, tunnel, excavation, or other public works
13 for this state. Before entering upon the performance of any such work".
- 14 Page 4, strike lines 1 through 3.
- 15 Page 4, line 4, after "contract," insert "A CONTRACTOR".
- 16 Page 4, strike lines 17 through 22 and substitute:
 - 17 "(3) THIS SECTION APPLIES TO:
 - 18 (a) A CONTRACTOR WHO IS AWARDED A CONTRACT FOR MORE
19 THAN FIFTY THOUSAND DOLLARS FOR THE CONSTRUCTION, ERECTION,
20 REPAIR, MAINTENANCE, OR IMPROVEMENT OF ANY BUILDING, ROAD,
21 BRIDGE, VIADUCT, TUNNEL, EXCAVATION, OR OTHER PUBLIC WORKS FOR
22 ANY COUNTY, CITY AND COUNTY, MUNICIPALITY, SCHOOL DISTRICT, OR
23 OTHER POLITICAL SUBDIVISION OF THE STATE;
 - 24 (b) A CONTRACTOR WHO IS AWARDED A CONTRACT FOR MORE
25 THAN ONE HUNDRED FIFTY THOUSAND DOLLARS FOR THE CONSTRUCTION,
26 ERECTION, REPAIR, MAINTENANCE, OR IMPROVEMENT OF ANY BUILDING,
27 ROAD, BRIDGE, VIADUCT, TUNNEL, EXCAVATION, OR OTHER PUBLIC WORKS
28 FOR THIS STATE; AND
 - 29 (c) ALL CONTRACTS FOR MORE THAN ONE HUNDRED FIFTY
30 THOUSAND DOLLARS AWARDED TO A PRIVATE ENTITY FOR THE
31 CONSTRUCTION, ERECTION, REPAIR, MAINTENANCE, OR IMPROVEMENT OF
32 ANY BUILDING, ROAD, BRIDGE, VIADUCT, TUNNEL, EXCAVATION, OR OTHER
33 PUBLIC WORKS THAT IS SITUATED OR LOCATED ON PUBLICLY OWNED
34 PROPERTY USING ANY PUBLIC OR PRIVATE MONEY OR PUBLIC OR PRIVATE
35 FINANCING.".
