SENATE COMMITTEE OF REFERENCE AMENDMENT

Committee on State, Veterans, & Military Affairs.

SB22-133 be amended as follows:

1 Amend printed bill, page 3, strike line 26 and substitute "requirements.".

2 Strike page 4.

3 Page 5, strike lines 1 through 14 and substitute:

4         "(c) IN ADDITION TO THE PROTECTION AND SECURITY SERVICES  
5 PROVIDED PURSUANT TO SUBSECTIONS (3)(a) AND (3)(b) OF THIS SECTION,  
6 THE COLORADO STATE PATROL MAY PROVIDE OTHER PROTECTION AND  
7 SECURITY SERVICES TO A MEMBER OF THE GENERAL ASSEMBLY AS  
8 REQUESTED BY THE EXECUTIVE COMMITTEE OF THE LEGISLATIVE COUNCIL  
9 AND AS DEEMED NECESSARY BY THE CHIEF OF THE COLORADO STATE  
10 PATROL.

11             (4) THE EXECUTIVE COMMITTEE OF THE LEGISLATIVE COUNCIL  
12 SHALL ESTABLISH A PROCESS BY WHICH A MEMBER OF THE GENERAL  
13 ASSEMBLY MAY REQUEST PROTECTION FROM THE COLORADO STATE  
14 PATROL PURSUANT TO SUBSECTION (3) OF THIS SECTION.

15             (5) THE COLORADO STATE PATROL SHALL ENSURE THAT MEMBERS  
16 OF THE GENERAL ASSEMBLY ARE AWARE OF THE PROTECTION AND  
17 SECURITY SERVICES THAT MAY BE REQUESTED FROM THE COLORADO  
18 STATE PATROL PURSUANT TO THIS SECTION.".

19 Page 5, strike lines 18 through 27.

20 Strike pages 6 and 7.

21 Page 8, strike lines 1 through 18 and substitute "**constitutional officers**  
22 - **definition.** (1) AS USED IN THIS SECTION, UNLESS THE CONTEXT  
23 OTHERWISE REQUIRES, "STATEWIDE CONSTITUTIONAL OFFICER" MEANS  
24 THE SECRETARY OF STATE, THE ATTORNEY GENERAL, AND THE STATE  
25 TREASURER.

26             (2) THE COLORADO STATE PATROL SHALL PROVIDE PROTECTION  
27 TO EACH STATEWIDE CONSTITUTIONAL OFFICER IF SUCH PROTECTION IS  
28 REQUESTED BY THE STATEWIDE CONSTITUTIONAL OFFICER.

29             (3) THE COLORADO STATE PATROL SHALL DESIGNATE STATE  
30 PATROL OFFICERS TO BE AVAILABLE TO PROVIDE PROTECTION SERVICES  
31 PURSUANT TO SUBSECTION (2) OF THIS SECTION. THE CHIEF OF THE  
32 COLORADO STATE PATROL SHALL DETERMINE THE PRIORITY IN ASSIGNING  
33 STATE PATROL OFFICERS AMONG EACH STATEWIDE CONSTITUTIONAL  
34 OFFICER. FACTORS TO BE CONSIDERED WHEN DETERMINING THE NEED AND  
35 PRIORITY FOR PROVIDING PROTECTION SERVICES INCLUDE, BUT ARE NOT

1 LIMITED TO, THE LOCATION OF THE FUNCTION, THE ESTIMATED LEVEL OF  
2 THREAT OR RISK ASSOCIATED WITH THE FUNCTION, AND STAFFING  
3 REQUIREMENTS. IF EACH STATEWIDE CONSTITUTIONAL OFFICER REQUESTS  
4 PROTECTION SERVICES IN EXCESS OF EIGHTY PERSONNEL HOURS A WEEK  
5 FOR EACH INDIVIDUAL, PRIORITY WILL BE GIVEN FIRST TO PROTECT  
6 AGAINST CREDIBLE THREATS, THEN AT A FUNCTION AT WHICH THE  
7 STATEWIDE CONSTITUTIONAL OFFICER IS IN ATTENDANCE IN AN OFFICIAL  
8 CAPACITY, AND FINALLY AGAINST GENERALIZED THREATS.

9 (4) NOTHING IN THIS SECTION IS INTENDED TO PROVIDE  
10 AROUND-THE-CLOCK PROTECTION FOR A STATEWIDE CONSTITUTIONAL  
11 OFFICER UNLESS THERE IS A CREDIBLE THREAT AS DETERMINED IN THE  
12 DISCRETION OF THE CHIEF OF THE COLORADO STATE PATROL.

13 (5) NOTHING IN THIS SECTION PROHIBITS A STATEWIDE  
14 CONSTITUTIONAL OFFICER FROM OBTAINING ADDITIONAL PROTECTION,  
15 WHICH MUST BE DONE IN COORDINATION WITH THE COLORADO STATE  
16 PATROL.".
