- 15 Page 1 of the amendment, lines 16 and 17, strike ""PHYSICIAN GROUP, OR
16 CHIEF MEDICAL OFFICER.". .". and substitute ""OR PHYSICIAN GROUP.".". .".
- 17 Page 1 of the amendment, after line 17, insert:
18 "Page 2 of the report, line 4, after "COLORADO" insert "WITHIN THE
19 PHYSICIAN ASSISTANT'S PRACTICE AREA".". .".
- 20 Page 1 of the amendment, line 20, strike ""PHYSICIAN, PHYSICIAN GROUP,
21 OR CHIEF MEDICAL OFFICER" and substitute ""PHYSICIAN OR PHYSICIAN
22 GROUP.".". .".
- 23 Page 1 of the amendment, line 22, strike ""PHYSICIAN, PHYSICIAN GROUP,
24 OR CHIEF MEDICAL OFFICER".". .". and substitute ""PHYSICIAN OR PHYSICIAN
25 GROUP.".". .".
- 26 Page 1 of the amendment, line 24, strike ""PHYSICIAN, PHYSICIAN GROUP,
