

SENATE COMMITTEE OF REFERENCE AMENDMENT

Committee on Transportation & Energy.

SB22-090 be amended as follows:

1 Amend printed bill, page 2, line 14, before "UTILITY'S" insert "RETAIL".

2 Page 2, after line 21 insert:

3 "(c) "RETAIL UTILITY" MEANS AN ELECTRIC OR GAS UTILITY IN THE
4 STATE THAT SELLS ELECTRICITY OR GAS AT RETAIL TO END USERS.".

5 Reletter succeeding paragraphs accordingly.

6 Page 3, after line 6 insert:

7 "(e) "WHOLESALE UTILITY" MEANS A UTILITY IN THE STATE THAT
8 SELLS ELECTRICITY OR GAS TO WHOLESALE CUSTOMERS FOR WHOLESALE
9 CUSTOMERS TO RESELL TO END USERS AT RETAIL.".

10 Page 4, after line 3 insert:

11 "(c) (I) ON AND AFTER JULY 1, 2022, IF A WHOLESALE UTILITY
12 RECEIVES INFORMATION ABOUT A SEVERE WEATHER EVENT OR
13 DETERMINES THAT A SEVERE WEATHER EVENT IS FORECASTED AND THAT
14 THE SEVERE WEATHER EVENT IS LIKELY TO RESULT IN A SIGNIFICANT
15 IMPACT TO THE WHOLESALE ELECTRIC OR GAS RATES CHARGED TO ITS
16 WHOLESALE CUSTOMERS, THE WHOLESALE UTILITY SHALL PROVIDE
17 WRITTEN NOTICE OF THE SEVERE WEATHER EVENT AND POTENTIAL RATE
18 IMPACTS TO ITS WHOLESALE CUSTOMERS AT LEAST FORTY-EIGHT HOURS
19 BEFORE THE SEVERE WEATHER EVENT IS FORECASTED TO REACH ONE OR
20 MORE COUNTIES OF THE STATE SERVED BY THE WHOLESALE UTILITY'S
21 RETAIL UTILITY CUSTOMERS.

22 (II) THE NOTIFICATION REQUIREMENT SET FORTH IN SUBSECTION
23 (2)(c)(I) OF THIS SECTION APPLIES ONLY WITH REGARD TO WHOLESALE
24 CUSTOMERS IN THE STATE THAT HAVE A MULTIYEAR WHOLESALE POWER
25 SUPPLY AGREEMENT OR A FULL OR PARTIAL REQUIREMENTS CONTRACT
26 WITH A WHOLESALE UTILITY.".

27 Before "UTILITY" insert "RETAIL" on: **Page 2**, line 11; **Page 3**, lines 4, 7,
28 9, 10, 11, 16, 17, 21, and 27; and **Page 4**, lines 4, 16, and 20.
