

SENATE COMMITTEE OF REFERENCE AMENDMENT

Committee on Judiciary.

SB22-067 be amended as follows:

1 Amend printed bill, strike everything below the enacting clause and
2 substitute:

3 "SECTION 1. In Colorado Revised Statutes, **add** 24-33.5-525 as
4 follows:

5 **24-33.5-525. Safe neighborhoods grant program - creation -**
6 **- appropriation - rules - report - definitions - repeal.** (1) THERE IS
7 CREATED IN THE DIVISION THE SAFE NEIGHBORHOODS GRANT PROGRAM TO
8 PROVIDE GRANTS TO LOCAL LAW ENFORCEMENT AGENCIES TO PROVIDE
9 CRITICAL INCIDENT TRAINING TO THE AGENCIES' PEACE OFFICERS.

10 (2) GRANT RECIPIENTS MUST USE THE MONEY RECEIVED THROUGH
11 THE GRANT PROGRAM FOR NECESSARY EXPENSES FOR CRITICAL INCIDENT
12 TRAINING, INCLUDING BUT NOT LIMITED TO TUITION, INSTRUCTOR COSTS,
13 CURRICULUM, MATERIALS, AND SUPPLIES.

14 (3) THE EXECUTIVE DIRECTOR SHALL PROMULGATE RULES AS ARE
15 REQUIRED IN THIS SECTION AND ADDITIONAL RULES AS MAY BE NECESSARY
16 TO IMPLEMENT THE GRANT PROGRAM. AT A MINIMUM, THE RULES MUST
17 SPECIFY THE FORM OF THE GRANT PROGRAM APPLICATION, THE TIME
18 FRAME FOR SUBMITTING AN APPLICATION, AND THE TIME FRAME FOR
19 DISTRIBUTING GRANT MONEY.

20 (4) TO RECEIVE A GRANT, A LOCAL LAW ENFORCEMENT AGENCY
21 MUST SUBMIT AN APPLICATION TO THE DIVISION.

22 (5) THE DIVISION SHALL REVIEW THE RECEIVED APPLICATIONS. IN
23 AWARDING GRANTS, THE DIVISION SHALL CONSIDER:

24 (a) THE INTENDED EXPENSES AND ASSOCIATED COSTS PROPOSED
25 BY THE APPLICANT; AND

26 (b) HOW TO AWARD GRANTS TO PROVIDE THE GREATEST
27 INTENDED IMPACT ACROSS COLORADO, RELATIVE TO THE TOTAL
28 APPROPRIATION FOR THE GRANT PROGRAM.

29 (6) ON OR BEFORE JANUARY 6, 2023, THE DIVISION SHALL AWARD
30 GRANTS AS PROVIDED IN THIS SECTION.

31 (7) ON OR BEFORE SEPTEMBER 1, 2023, EACH LOCAL LAW
32 ENFORCEMENT AGENCY THAT RECEIVES A GRANT THROUGH THE GRANT
33 PROGRAM SHALL SUBMIT A REPORT TO THE DIVISION. AT A MINIMUM, THE
34 REPORT MUST INCLUDE:

35 (a) A DESCRIPTION OF EXPENSES AND THE ASSOCIATED COSTS OF
36 THE EXPENSES MADE WITH GRANT MONEY; AND

37 (b) ANY EVIDENCE OR NARRATIVES DEMONSTRATING THE IMPACT
38 OF THE CRITICAL INCIDENT TRAINING RECEIVED AS A RESULT OF A GRANT.

39 (8) ON OR BEFORE JANUARY 5, 2024, THE DIVISION SHALL SUBMIT
40 A REPORT TO THE JUDICIARY COMMITTEES OF THE SENATE AND THE HOUSE

1 OF REPRESENTATIVES, OR ANY SUCCESSOR COMMITTEES, REGARDING THE
2 GRANT PROGRAM. AT A MINIMUM, THE REPORT MUST SUMMARIZE THE
3 INFORMATION REPORTED BY LOCAL LAW ENFORCEMENT AGENCIES
4 PURSUANT TO SUBSECTION (7) OF THIS SECTION.

5 (9) FOR THE 2022-23 STATE FISCAL YEAR, THE GENERAL
6 ASSEMBLY SHALL APPROPRIATE FIFTY MILLION DOLLARS TO THE DIVISION
7 FOR THE PURPOSES OF THIS SECTION. THE DIVISION MAY NOT USE MORE
8 THAN THREE PERCENT OF THE APPROPRIATION FOR COSTS TO ADMINISTER
9 THE GRANT PROGRAM.

10 (10) AS USED IN THIS SECTION, UNLESS THE CONTEXT OTHERWISE
11 REQUIRES:

12 (a) "CRITICAL INCIDENT" MEANS AN INCIDENT THAT HAS THE
13 POTENTIAL TO RESULT IN ESCALATED CONFLICT, INCLUDING THE
14 POTENTIAL FOR INJURY OR DEATH, BETWEEN A PEACE OFFICER AND THE
15 PERSON WITH WHOM THE PEACE OFFICER INTERACTS. "CRITICAL INCIDENT"
16 INCLUDES, BUT IS NOT LIMITED TO, CIRCUMSTANCES INVOLVING A
17 WEAPON, PEACE OFFICER INTERACTIONS WITH PERSONS WITH DISABILITIES,
18 AND PEACE OFFICER INTERACTIONS WITH PERSONS WHO ARE ELDERLY.

19 (b) "GRANT PROGRAM" MEANS THE SAFE NEIGHBORHOODS GRANT
20 PROGRAM CREATED IN SUBSECTION (1) OF THIS SECTION.

21 (c) "LOCAL LAW ENFORCEMENT AGENCY" MEANS A COUNTY
22 SHERIFF'S OFFICE, MUNICIPAL POLICE FORCE, OR POLICE DEPARTMENT FOR
23 A STATE INSTITUTION OF HIGHER EDUCATION, AS DEFINED BY SECTION
24 23-5-141 (2)(c).

25 (11) THIS SECTION IS REPEALED, EFFECTIVE JUNE 30, 2024.

26 **SECTION 2. Act subject to petition - effective date.** This act
27 takes effect at 12:01 a.m. on the day following the expiration of the
28 ninety-day period after final adjournment of the general assembly; except
29 that, if a referendum petition is filed pursuant to section 1 (3) of article V
30 of the state constitution against this act or an item, section, or part of this
31 act within such period, then the act, item, section, or part will not take
32 effect unless approved by the people at the general election to be held in
33 November 2022 and, in such case, will take effect on the date of the
34 official declaration of the vote thereon by the governor."
