

HOUSE COMMITTEE OF REFERENCE AMENDMENT
Committee on Finance.

HB24-1335 be amended as follows:

1 Amend printed bill, page 7, after line 27 insert:

2 **"SECTION 11.** In Colorado Revised Statutes, 12-135-112, **repeal**
3 (1)(a); and **add** (4) as follows:

4 **12-135-112. Standards of practice - embalming - transporting.**

5 (1) A funeral establishment that performs embalming shall:

6 (a) ~~Maintain a sanitary preparation room with sanitary flooring,~~
7 ~~drainage, and ventilation;~~

8 (4) A FUNERAL ESTABLISHMENT SHALL MAINTAIN A SANITARY
9 PREPARATION ROOM WITH SANITARY FLOORING, DRAINAGE, VENTILATION,
10 AND REFRIGERATION AND OTHER EQUIPMENT NECESSARY TO MAINTAIN
11 SANITARY CONDITIONS.

12 **SECTION 12.** In Colorado Revised Statutes, 12-135-113, **add** (4)
13 as follows:

14 **12-135-113. Custody and responsibility - rules.** (4) A FUNERAL
15 ESTABLISHMENT SHALL NOT TAKE CUSTODY OF MORE HUMAN REMAINS
16 THAN THE FUNERAL ESTABLISHMENT HAS CAPACITY TO REFRIGERATE
17 UNLESS THE FUNERAL ESTABLISHMENT MAINTAINS CUSTODY OF THE
18 HUMAN REMAINS FOR LESS THAN TWENTY-FOUR HOURS.

19 **SECTION 13.** In Colorado Revised Statutes, **add** 12-135-114 as
20 follows:

21 **12-135-114. Insurance requirements.** (1) A FUNERAL
22 ESTABLISHMENT SHALL OBTAIN AND MAINTAIN A PROFESSIONAL LIABILITY
23 INSURANCE POLICY WITH LIABILITY LIMITS OF AT LEAST ONE MILLION
24 DOLLARS. THE FUNERAL ESTABLISHMENT MUST SUBMIT THE CERTIFICATE
25 OF PROFESSIONAL LIABILITY INSURANCE TO THE DIRECTOR:

26 (a) WITHIN THIRTY DAYS AFTER THE INITIAL REGISTRATION OF THE
27 FUNERAL ESTABLISHMENT BY THE BOARD; AND

28 (b) UPON REQUEST BY THE DIRECTOR.

29 (2) A FUNERAL ESTABLISHMENT SHALL NOTIFY THE BOARD IN
30 WRITING WITHIN THIRTY DAYS AFTER DOING ANY OF THE FOLLOWING FOR
31 THE PROFESSIONAL LIABILITY INSURANCE POLICY REQUIRED BY
32 SUBSECTION (1) OF THIS SECTION:

33 (a) CHANGING THE POLICY OR THE INSURER THAT ISSUES THE
34 POLICY; OR

35 (b) CANCELING OR SUSPENDING THE POLICY.".

36 Renumber succeeding sections accordingly.
