

HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on Finance.

HB24-1335 be amended as follows:

1 Amend printed bill, page 7, after line 8 insert:

2 "SECTION 9. In Colorado Revised Statutes, 12-135-104, **add**  
3 (1.5) as follows:

4 **12-135-104. Funeral establishment - subcontractor.** (1.5) A  
5 FUNERAL ESTABLISHMENT SHALL HAVE A WRITTEN CONTRACT WITH ALL  
6 SUBCONTRACTORS OR AGENTS. THE CONTRACT MUST BE SIGNED BY THE  
7 ESTABLISHMENT'S DESIGNEE AND MADE, UPON REQUEST, AVAILABLE TO A  
8 CONSUMER THAT IS AFFECTED BY THE CONTRACT OR THE DIRECTOR."

9 Renumber succeeding sections accordingly.

10 Page 7, line 19, strike "(4)(b)" and substitute "(4)(b); and **add (6)**".

11 Page 7, after line 27 insert:

12 "(6) THIS PART 1 DOES NOT APPLY TO OR INTERFERE WITH CRYONIC  
13 PRESERVATION OF HUMAN REMAINS IF DONE PURSUANT TO RULE."

14 Page 8, after line 8 insert:

15 "SECTION 13. In Colorado Revised Statutes, 12-135-307,  
16 **amend** (5)(b) as follows:

17 **12-135-307. Standards of practice - cremating.** (5) (b) After  
18 ~~cremation is complete, all of the cremains and reasonable recoverable~~  
19 ~~residue shall be removed from the cremation chamber and processed as~~  
20 ~~necessary. Anything other than the cremains shall be disposed of unless~~  
21 ~~the next of kin authorizes otherwise.~~ UPON THE COMPLETION OF EACH  
22 CREMATION, THE CREMATIONIST SHALL REMOVE ALL OF THE  
23 RECOVERABLE RESIDUE, INsofar AS IS PRACTICABLE, OF THE CREMATION  
24 PROCESS FROM THE CREMATORY AND PLACE THE RESIDUE IN A SEPARATE  
25 CONTAINER SO THAT THE RESIDUE DOES NOT COMMINGLE WITH THE  
26 CREMATED REMAINS OF OTHER INDIVIDUALS. THE CREMATIONIST SHALL  
27 DISPOSE OF ACCUMULATED RESIDUE IN ACCORDANCE WITH THE  
28 REGULATIONS OF A CEMETERY WITH A DEFINED AREA TO SCATTER  
29 REMAINS AND RESIDUE AND ANY APPLICABLE LOCAL ORDINANCES."

30 Renumber succeeding section accordingly.
