HB24-1307 be amended as follows:

- 1 Amend reengrossed bill, page 4, line 24, strike "school administrative
- 2 entities" and substitute "local education providers, including the Colorado
- 3 school for the deaf and the blind,".
- 4 Page 5, line 1, strike "school administrative entities" and substitute "local
- 5 education providers, including the Colorado school for the deaf and the
- 6 blind,".
- 7 Page 5, line 5, after "contractors" insert "or the negotiation of a project
- 8 labor agreement".
- 9 Page 5, line 8, strike "and".
- 10 Page 5, strike line 12 and substitute:
- 11 "students and staff; and
- 12 (e) Allows Colorado's school districts to choose to undergo an
- 13 HVAC assessment and find a pathway to fund any improvements
- 14 identified without mandating that any school must undergo an assessment
- 15 or HVAC improvements.".
- 16 Page 7, after line 1, insert:
- 17 "(l) "LOCAL EDUCATION PROVIDER" MEANS:
- 18 (a) A LOCAL EDUCATION PROVIDER, AS DEFINED IN SECTION
- 19 22-16-103 (4); AND
- 20 (b) THE COLORADO SCHOOL FOR THE DEAF AND THE BLIND
- 21 CREATED IN SECTION 22-80-102.".
- 22 Reletter succeeding paragraphs accordingly.
- 23 Page 8, strike lines 9 through 17.
- 24 Reletter succeeding paragraph accordingly.
- 25 Page 19, line 10, strike "LIST;" and substitute "LIST TO ASSIST IN
- 26 CONTRACTOR SELECTION AND ENSURE COMPLIANCE WITH FEDERAL
- 27 FUNDING REQUIREMENTS;".
- 28 Page 19, line 12, after "CONTRACTORS" insert "OR CONTRACTORS THAT
- 29 USE PREVAILING WAGES AND APPRENTICES REGISTERED WITH THE

1 FEDERAL DEPARTMENT OF LABOR OR THE STATE APPRENTICESHIP AGENCY
2 CREATED IN SECTION 8-15.7-102".

3 Page 19, line 17, strike "PROGRAMS." and substitute "PROGRAMS TO
4 ASSIST IN CONTRACTOR SELECTION AND ENSURE COMPLIANCE WITH
5 FEDERAL FUNDING REQUIREMENTS."

6 Page 19, line 20, strike "AGREEMENT." and substitute "AGREEMENT,
7 WHICH ALLOWS A CONTRACTOR AND ALL SUBCONTRACTORS TO COMPETE
8 FOR CONTRACTS AND SUBCONTRACTS WITHOUT REGARD TO WHETHER
9 THEY ARE PARTIES TO A COLLECTIVE BARGAINING AGREEMENT."

10 Page 21, lines 2 and 3, strike "OUTLINED IN FEDERAL FUNDING
11 GUIDANCE," and substitute "REQUIRED IN ORDER FOR THE LOCAL
12 EDUCATION PROVIDER TO REMAIN COMPETITIVE FOR FEDERAL FUNDING
13 SOURCES, SPECIFICALLY GRANTS PROGRAMS UNDER THE FEDERAL
14 "INFRASTRUCTURE INVESTMENT AND JOBS ACT", PUB.L. 117-58, AND
15 RECEIVE FULL PREFERENCE POINTS FOR PROGRAMS UNDER THE FEDERAL
16 "INFLATION REDUCTION ACT," INCLUDED THEREIN,".

17 Page 21, line 16, strike "SCHOOL ADMINISTRATIVE ENTITIES" and
18 substitute "LOCAL EDUCATION PROVIDERS".

19 Page 23, line 21, strike "SCHOOL" and substitute "SCHOOLS".

20 Page 23, line 26, strike "SCHOOL DISTRICT," and substitute "LOCAL
21 EDUCATION PROVIDER,".

22 Page 24, line 8, strike "THE" and substitute "AS PART OF THE REPORT
23 ISSUED PURSUANT TO SUBSECTION (7)(a) OF THIS SECTION, THE".

24 Page 24, lines 10 and 11, strike "SCHOOL DISTRICTS" and substitute
25 "LOCAL EDUCATION PROVIDERS".

26 Strike "SCHOOL ADMINISTRATIVE ENTITY" and substitute "LOCAL
27 EDUCATION PROVIDER" on **Page 8**, lines 8, 22, and 26 and 27; **Page 9**,
28 lines 4 and 5 and 6; **Page 16**, lines 11 and 12; **Page 18**, lines 9 and 25;
29 **Page 19**, lines 4 and 5, 9, and 23; **Page 20**, line 26; **Page 21**, lines 1 and
30 11 and 12.
