Committee on Education.

HB24-1307 be amended as follows:

- 1 Amend printed bill, page 7, line 6, after "GYMNASIUMS," insert  
2 "CAFETERIAS,".
- 3 Page 12, line 24, strike "ALL CLASSROOMS" and substitute "OCCUPIED  
4 AREAS, AS DETERMINED BY QUALIFIED PERSONNEL,".
- 5 Page 13, line 10, strike "CLASSROOM" and substitute "OCCUPIED AREAS,  
6 AS DETERMINED BY QUALIFIED PERSONNEL,".
- 7 Page 13, line 27, strike "CLASSROOMS" and substitute "OCCUPIED AREAS".
- 8 Page 14, line 5, strike "ALL CLASSROOMS." and substitute "OCCUPIED  
9 AREAS, AS APPLICABLE.".
- 10 Page 15, line 2, strike "ALL CLASSROOMS;" and substitute "OCCUPIED  
11 AREAS;".
- 12 Page 18, line 4, strike "If A CLASSROOM" and substitute "FOR CO2  
13 MONITORS INSTALLED IN OCCUPIED AREAS, AS DETERMINED BY QUALIFIED  
14 PERSONNEL, IF THE".
- 15 Page 18, line 7, strike "CLASSROOM" and substitute "OCCUPIED AREA'S".
- 16 Page 18, line 9, strike "CLASSROOM" and substitute "OCCUPIED AREA".
- 17 Page 18, line 11, strike "CLASSROOM".
- 18 Page 19, strike lines 13 and 14 and substitute "SOURCES;".
- 19 Page 20, line 13, strike "DESCRIPTION OF HOW" and substitute  
20 "STATEMENT ACKNOWLEDGING THAT".
- 21 Page 20, after line 23 insert:  
22 "(11) **Notices of receipt of federal grant funding.** A SCHOOL  
23 ADMINISTRATIVE ENTITY THAT RECEIVES FEDERAL GRANT FUNDING FOR  
24 HVAC IMPROVEMENTS SHALL NOTIFY THE DEPARTMENT OF THE RECEIPT  
25 OF THE FUNDING. THE DEPARTMENT SHALL PUBLISH ON ITS PUBLIC  
26 WEBSITE NOTIFICATIONS OF ALL FEDERAL GRANT FUNDING THAT IS  
27 AWARDED TO SCHOOL ADMINISTRATIVE ENTITIES FOR HVAC  
28 IMPROVEMENTS.".
- 29 Page 22, line 22, strike "SCHOOLS" and substitute "SCHOOLS, INCLUDING  
30 SUCH ENTITIES".
