HB25-1076 be amended as follows:

1 Amend printed bill, page 11, before line 1 insert:

2       **"SECTION 12.** In Colorado Revised Statutes, **amend** 42-1-222  
3 as follows:

4       **42-1-222. Motor vehicle investigations unit.** (1) The department  
5 shall establish a motor vehicle investigations unit to investigate and  
6 prevent fraud concerning the use of ~~driver's licenses, identification cards,~~  
7 ~~motor vehicle titles and registrations, and other motor vehicle~~ OFFICIAL  
8 documents, AS DEFINED IN SECTION 18-5-121 (1)(b), issued by the  
9 department ~~Such~~ OR THE DEPARTMENT'S AGENTS. THE unit shall also  
10 assist victims of identity theft by means of such documents.

11       (2) THE MOTOR VEHICLE INVESTIGATIONS UNIT MAY CANCEL,  
12 DENY, OR DENY THE ISSUANCE OR REISSUANCE OF AN OFFICIAL DOCUMENT,  
13 AS DEFINED IN SECTION 18-5-121 (1)(b), UPON DETERMINING THAT THE  
14 PERSON WAS NOT ENTITLED TO THE ISSUANCE OF THE OFFICIAL DOCUMENT  
15 FOR:

16       (a) FAILURE TO GIVE THE REQUIRED OR CORRECT INFORMATION IN  
17 AN APPLICATION FOR THE OFFICIAL DOCUMENT OR FOR COMMITTING  
18 FRAUD IN MAKING THE APPLICATION OR IN SUBMITTING ANY PROOF FOR  
19 THE APPLICATION; OR

20       (b) PERMITTING AN UNLAWFUL OR FRAUDULENT USE OF THE  
21 OFFICIAL DOCUMENT OR FOR BEING CONVICTED OF AN OFFENSE INVOLVING  
22 MISUSE OF THE OFFICIAL DOCUMENT.

23       (3) IF THE MOTOR VEHICLE INVESTIGATIONS UNIT CANCELS,  
24 DENIES, OR DENIES THE ISSUANCE OR REISSUANCE OF AN OFFICIAL  
25 DOCUMENT, AS DEFINED IN SECTION 18-5-121 (1)(b), THE AFFECTED  
26 PERSON MAY REQUEST A HEARING PURSUANT TO SECTION 24-4-105.".

27 Renumber succeeding section accordingly.
