

SENATE COMMITTEE OF REFERENCE AMENDMENT

Committee on Agriculture & Natural Resources.

SB23-159 be amended as follows:

1 Amend printed bill, page 2, line 3, strike "(21)" and substitute  
2 "(17)(a)(VII)".

3 Page 2, strike lines 10 through 16 and substitute:

4 "(17)(a) The following statutory authorizations for the designated  
5 advisory committees will repeal on September 1, 2026:

6 (VII) THE COLORADO FOOD SYSTEMS ADVISORY COUNCIL  
7 CREATED IN SECTION 23-31-1102.

8 **SECTION 2.** In Colorado Revised Statutes, 23-31-1102, **amend**  
9 (2)(b) introductory portion; and **add** (2)(b)(XII) and (2.1) as follows:

10 **23-31-1102. Colorado food systems advisory council - created**  
11 **- membership - terms - vacancies.** (2) The council consists of:

12 (b) ~~Sixteen~~ SEVENTEEN members appointed ON A ROTATING BASIS  
13 IN THE ORDER LISTED IN THIS SUBSECTION (2)(b), AS NEW POSITIONS OR  
14 VACANCIES ARISE, by ~~the governor or the governor's designee~~ THE  
15 SPEAKER OF THE HOUSE OF REPRESENTATIVES, THE MINORITY LEADER OF  
16 THE HOUSE OF REPRESENTATIVES, THE PRESIDENT OF THE SENATE, AND  
17 THE MINORITY LEADER OF THE SENATE, as follows:

18 (XII) ONE MEMBER WHO IS A REPRESENTATIVE OF A FOOD BANK.

19 (2.1) IF TWO NEW POSITIONS OR VACANCIES LISTED IN SUBSECTION  
20 (2)(b) OF THIS SECTION OPEN SIMULTANEOUSLY, THE INDIVIDUAL FIRST  
21 SCHEDULED TO APPOINT PURSUANT TO SUBSECTION (2)(b) OF THIS SECTION  
22 SHALL CHOOSE WHICH POSITION TO APPOINT.

23 **SECTION 3.** In Colorado Revised Statutes, 23-31-1104, **repeal**  
24 (2) as follows:

25 **23-31-1104. Subcommittees of the council.** (2) ~~The council may~~  
26 ~~engage in any other activity the council determines is necessary to~~  
27 ~~accomplish the purposes outlined in this part 11.~~".

28 Rerumber succeeding sections accordingly.

29 Page 2, line 20, strike "2030." and substitute "2026.".

30 Page 1, strike line 103 and substitute "**EXTENDING THE SUNSET DATE BY**  
31 **THREE YEARS.**".
