

SENATE COMMITTEE OF REFERENCE AMENDMENT  
Committee on Judiciary.

SB22-018 be amended as follows:

1 Amend printed bill, page 2, lines 4 and 5, strike "and (14)(f)(VI)" and  
2 substitute "(14)(f)(VI), and (14)(i)".

3 Page 5, after line 23 insert:

4         "(i) (I) THE STATE COURT ADMINISTRATOR SHALL CONVENE A  
5 WORKING GROUP TO STUDY BEST PRACTICES IN COURT REMINDERS, ASSESS  
6 THE EFFECTIVENESS OF THE COURT REMINDER PROGRAM ESTABLISHED IN  
7 THIS SUBSECTION (14), AND RECOMMEND TO THE STATE COURT  
8 ADMINISTRATOR'S OFFICE ANY APPROPRIATE CHANGES TO THE COURT  
9 REMINDER PROGRAM. THE JUDICIAL DEPARTMENT SHALL PROVIDE STAFF  
10 SUPPORT NECESSARY FOR THE WORKING GROUP TO CARRY OUT ITS DUTIES.

11         (II) THE WORKING GROUP CONSISTS OF THE STATE COURT  
12 ADMINISTRATOR OR THE ADMINISTRATOR'S DESIGNEE; A PUBLIC DEFENDER  
13 APPOINTED BY THE STATE PUBLIC DEFENDER; A MEMBER OF A STATEWIDE  
14 ORGANIZATION OF PRETRIAL SERVICES ORGANIZATIONS, APPOINTED BY  
15 THE ORGANIZATION; THE EXECUTIVE DIRECTOR OF THE COLORADO  
16 DISTRICT ATTORNEYS' COUNCIL OR THE EXECUTIVE DIRECTOR'S DESIGNEE;  
17 AND ONE MEMBER, APPOINTED BY THE SPEAKER OF THE HOUSE OF  
18 REPRESENTATIVES, WHO REPRESENTS A COLORADO-BASED NONPROFIT  
19 ORGANIZATION WITH EXPERTISE IN PRETRIAL RELEASE AND COURT  
20 REMINDER PROGRAMS.

21         (III) ON OR BEFORE JULY 31, 2022, THE APPOINTING AUTHORITIES  
22 SHALL MAKE APPOINTMENTS TO THE WORKING GROUP AND INFORM THE  
23 STATE COURT ADMINISTRATOR OF THE APPOINTMENTS.

24         (IV) THE WORKING GROUP SHALL MEET QUARTERLY. THE STATE  
25 COURT ADMINISTRATOR, OR THE ADMINISTRATOR'S DESIGNEE, SHALL  
26 CONVENE THE FIRST WORKING GROUP MEETING NO LATER THAN  
27 SEPTEMBER 30, 2022, AND SHALL CONVENE EACH MEETING OF THE  
28 WORKING GROUP THEREAFTER.

29         (V) THE WORKING GROUP MAY REQUEST DATA AND INFORMATION  
30 FROM THE JUDICIAL DEPARTMENT ABOUT THE COURT REMINDER PROGRAM.

31         (VI) IN ITS ANNUAL REPORT TO THE COMMITTEES OF REFERENCE  
32 PURSUANT TO SECTION 2-7-203, THE JUDICIAL DEPARTMENT SHALL  
33 PRESENT THE RECOMMENDATIONS MADE BY THE WORKING GROUP,  
34 WHETHER THE RECOMMENDATIONS WERE IMPLEMENTED, AND THE  
35 RATIONALE FOR IMPLEMENTING OR REJECTING ANY RECOMMENDATION.

36         (VII) THIS SUBSECTION (14)(i) IS REPEALED, EFFECTIVE JUNE 30,  
37 2025.".
