

HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on Public & Behavioral Health & Human Services.

HB22-1056 be amended as follows:

1 Amend printed bill, strike everything below the enacting clause and
2 substitute:

3 **"SECTION 1.** In Colorado Revised Statutes, 19-2.5-1407, **amend**
4 **(1); and add (3) as follows:**

5 **19-2.5-1407. Appropriations to department of human services**
6 **for services to juveniles - definition - repeal.** (1) The general assembly
7 shall appropriate money for the provision of services to juveniles to the
8 department of human services. The department of human services shall
9 allocate such money by each judicial district in the state. The
10 appropriation and allocation must be made based upon the formula
11 developed pursuant to ~~section 19-2.5-1404 (1)(b)~~ SECTION 19-2.5-1404
12 (1)(b)(V). The department of human services shall administer the
13 appropriated money. The money appropriated to the department of human
14 services for allocation by each judicial district must be expended in the
15 judicial district by the department of human services for services to
16 juveniles that are intended to prevent the juvenile from being held in
17 detention prior to adjudication, INCLUDING IMPLEMENTING OPTIONS
18 PROVIDED IN THE SCREENING INSTRUMENT DESCRIBED IN SECTION
19 19-2.5-1404; sentenced to detention; or committed to the department of
20 human services or to reduce the length of time the juvenile is held in
21 preadjudication or postadjudication detention or held in a commitment
22 facility operated pursuant to section 19-2.5-1502. If a judicial district has
23 a local juvenile services planning committee, the expenditure of money
24 for juvenile services in the judicial district must be made in accordance
25 with the plan developed pursuant to section 19-2.5-302.

26 (3) (a) THE GENERAL ASSEMBLY SHALL ANNUALLY APPROPRIATE
27 MONEY TO THE DEPARTMENT OF HUMAN SERVICES FOR THE PROVISION OF
28 TEMPORARY SHELTER FOR JUVENILES BY JUDICIAL DISTRICTS. THE
29 GENERAL ASSEMBLY SHALL APPROPRIATE AN AMOUNT SUFFICIENT TO
30 FUND FIVE NIGHTS OF CARE FOR EACH JUVENILE WHO, BASED ON THE
31 RESULTS OF A SCREENING BY THE JUDICIAL DISTRICT'S SCREENING TEAM,
32 IS SCREENED TO TEMPORARY CARE IN A LICENSED TEMPORARY SHELTER
33 FACILITY.

34 (b) ON OR BEFORE NOVEMBER 1, 2022, AND ANNUALLY
35 THEREAFTER, THE DEPARTMENT SHALL ALLOCATE MONEY TO JUDICIAL
36 DISTRICTS IN ACCORDANCE WITH THE FORMULA DEVELOPED PURSUANT TO
37 SECTION 19-2.5-1404 (1)(b)(X).

38 (c) (I) (A) IN ORDER TO RECEIVE AN ALLOCATION FOR STATE
39 FISCAL YEAR 2022-23, A JUDICIAL DISTRICT'S JUVENILE SERVICES

1 PLANNING COMMITTEE, OR THE JUDICIAL DISTRICT IF THE JUDICIAL
2 DISTRICT HAS NOT ESTABLISHED A JUVENILE SERVICES PLANNING
3 COMMITTEE, SHALL SUBMIT A PLAN TO THE DEPARTMENT NO LATER THAN
4 SEPTEMBER 1, 2022, THAT DETAILS HOW THE JUDICIAL DISTRICT WILL
5 PROVIDE TEMPORARY SHELTER IN THE DISTRICT DURING STATE FISCAL
6 YEAR 2022-23. THE PLAN MUST INCLUDE THAT PLACEMENT IN LICENSED
7 SHELTER CARE IS VOLUNTARY AND MUST NOT EXCEED FIVE DAYS.

8 (B) THIS SUBSECTION (3)(c)(I) IS REPEALED, EFFECTIVE JULY 1,
9 2023.

10 (II) FOR STATE FISCAL YEAR 2023-24 AND EACH YEAR
11 THEREAFTER, IN ORDER TO RECEIVE AN ALLOCATION, A JUVENILE SERVICES
12 PLANNING COMMITTEE, OR THE JUDICIAL DISTRICT IF THE JUDICIAL
13 DISTRICT HAS NOT ESTABLISHED A JUVENILE SERVICES PLANNING
14 COMMITTEE, SHALL INCLUDE IN ITS PLAN DEVELOPED PURSUANT TO
15 SECTION 19-2.5-302 A PLAN FOR PROVIDING TEMPORARY SHELTER IN THE
16 JUDICIAL DISTRICT. THE PLAN MUST INCLUDE THAT PLACEMENT IN
17 LICENSED SHELTER CARE IS VOLUNTARY AND MUST NOT EXCEED FIVE
18 DAYS.

19 (d) A JUDICIAL DISTRICT'S JUVENILE SERVICES PLANNING
20 COMMITTEE, OR THE JUDICIAL DISTRICT, MAY USE MONEY ALLOCATED
21 PURSUANT TO THIS SUBSECTION (3) FOR:

22 (I) THE COST OF CARE IN A LICENSED TEMPORARY SHELTER,
23 INCLUDING ANY TRANSPORTATION COSTS, FOR UP TO FIVE NIGHTS FOR
24 EACH JUVENILE WHO, AFTER SCREENING BY THE JUDICIAL DISTRICT'S
25 SCREENING TEAM, IS REFERRED TO RECEIVE TEMPORARY CARE IN A
26 LICENSED TEMPORARY SHELTER FACILITY;

27 (II) PROVIDING SUPPORT TO A GRANDPARENT, KIN, OR OTHER
28 SUITABLE PERSON FOR CARE OF A JUVENILE RELEASED TO THE PERSON'S
29 CARE WHILE EMERGENCY CIRCUMSTANCES EXIST, AS DETERMINED BY THE
30 JUDICIAL DISTRICT'S JUVENILE SERVICES PLANNING COMMITTEE THAT
31 PREVENT THE JUVENILE FROM RETURNING HOME. SUPPORT PROVIDED TO
32 A GRANDPARENT, KIN, OR OTHER SUITABLE PERSON MUST BE BASED ON
33 THE ACTUAL COSTS INCURRED BY THE PERSON FOR CARING FOR THE
34 JUVENILE.

35 (III) SERVICES FOR AND EVALUATION OF A JUVENILE RECEIVING
36 TEMPORARY SHELTER; AND

37 (IV) ESTABLISHING LICENSED TEMPORARY SHELTER THROUGH
38 EVALUATION OR RECRUITMENT AND PROVIDING TRAINING NEEDED TO
39 OPERATE TEMPORARY SHELTER.

40 (e) (I) ON OR BEFORE JANUARY 31, 2024, AND ON OR BEFORE
41 JANUARY 31 OF EACH YEAR THEREAFTER, THE HOUSE OF
42 REPRESENTATIVES PUBLIC AND BEHAVIORAL HEALTH AND HUMAN
43 SERVICES COMMITTEE AND THE SENATE HEALTH AND HUMAN SERVICES

1 COMMITTEE, OR THEIR SUCCESSOR COMMITTEES, SHALL HOLD A JOINT
2 HEARING TO DETERMINE WHETHER THE RECOMMENDATIONS OF THE
3 WORKING GROUP DESCRIBED IN SECTION 19-2.5-1404 HAVE BEEN
4 IMPLEMENTED IN A MANNER THAT WARRANTS THE REPEAL OF THIS
5 SUBSECTION (3) PRIOR TO ITS SCHEDULED REPEAL IN 2026. AT THE
6 HEARING THAT OCCURS DURING THE 2026 REGULAR LEGISLATIVE SESSION,
7 THE COMMITTEES SHALL CONSIDER WHETHER THIS SUBSECTION (3)
8 SHOULD BE CONTINUED.

9 (II) AT THE HEARING, THE DEPARTMENT SHALL PRESENT ON ITS
10 MOST RECENT REPORT ISSUED PURSUANT TO SECTION 19-2.5-1404 (3)(b),
11 THE COMMITTEES SHALL PERMIT REPRESENTATIVES OF THE WORKING
12 GROUP TO TESTIFY OR PROVIDE INFORMATION TO THE COMMITTEES, AND
13 THE COMMITTEES SHALL TAKE PUBLIC TESTIMONY REGARDING
14 IMPLEMENTATION OF THE WORKING GROUP'S RECOMMENDATIONS.

15 (f) THIS SUBSECTION (3) IS REPEALED, EFFECTIVE JUNE 30, 2026.

16 **SECTION 2.** In Colorado Revised Statutes, 19-2.5-1404, **add**
17 (1)(b)(X) as follows:

18 **19-2.5-1404. Working group for criteria for placement of**
19 **juvenile offenders - establishment of formula - review of criteria -**
20 **report.** (1) (b) The working group shall carry out the following duties:

21 (X) BEFORE JULY 1, 2022, TO CREATE A FORMULA FOR THE
22 ALLOCATION OF MONEY TO JUDICIAL DISTRICTS PURSUANT TO SECTION
23 19-2.5-1407 (3) FOR THE PROVISION OF TEMPORARY SHELTER FOR
24 JUVENILES.

25 **SECTION 3. Safety clause.** The general assembly hereby finds,
26 determines, and declares that this act is necessary for the immediate
27 preservation of the public peace, health, or safety.".
