

HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on Appropriations.

SB22-232 be amended as follows:

1 Amend reengrossed bill, page 6, strike line 27.

2 Strike page 7 and substitute:

3 "(b) THE BOARD CONSISTS OF THIRTEEN PERSONS.

4 (c) THE GOVERNOR SHALL APPOINT TO THE BOARD, WITH THE  
5 CONSENT OF THE SENATE:

6 (I) AT LEAST ONE MEMBER WITH EXPERIENCE IN ONE OF EACH OF  
7 THE FOLLOWING AREAS:

8 (A) THE DEVELOPMENT OF RENTAL HOUSING;

9 (B) REAL ESTATE TRANSACTIONS; AND

10 (C) PUBLIC FINANCE; AND

11 (II) AT LEAST ONE MEMBER WHICH MEETS ONE OF THE FOLLOWING  
12 CRITERIA:

13 (A) BE THE DIRECTOR OF A LOCAL HOUSING AUTHORITY;

14 (B) BE AN ELECTED COUNTY COMMISSIONER FROM A COUNTY IN  
15 THE STATE; AND

16 (C) BE A REPRESENTATIVE FROM A NONPROFIT ORGANIZATION  
17 THAT HAS EXPERIENCE DEVELOPING MIDDLE-INCOME HOUSING.

18 (d) IN ADDITION TO THE APPOINTMENTS SET FORTH IN SUBSECTION  
19 (2)(c)(I) OF THIS SECTION, THE GOVERNOR SHALL APPOINT TO THE BOARD:

20 (I) THE DIRECTOR OF THE OFFICE OF ECONOMIC DEVELOPMENT  
21 ESTABLISHED IN SECTION 24-48.5-101 (1), OR THE DIRECTOR'S DESIGNEE;  
22 AND

23 (II) THE DIRECTOR OF THE DIVISION OF HOUSING ESTABLISHED IN  
24 SECTION 24-32-704, OR THE DIRECTOR'S DESIGNEE.

25 (e) IN ADDITION TO THE REQUIREMENTS OF THIS SUBSECTION (2)  
26 OF THIS SECTION, WHEN MAKING APPOINTMENTS TO THE BOARD,  
27 REASONABLE EFFORTS MUST BE MADE TO APPOINT MEMBERS THAT  
28 REFLECT THE GEOGRAPHIC AND DEMOGRAPHIC DIVERSITY OF THE ENTIRE  
29 STATE.

30 (f) (I) EACH MEMBER IS APPOINTED FOR A TERM OF FOUR YEARS;  
31 EXCEPT THAT THE TERMS SHALL BE STAGGERED SO THAT NO MORE THAN  
32 FIVE MEMBERS' TERMS EXPIRE IN THE SAME YEAR."

33 Page 8, strike lines 1 through 5 and substitute:

34 "(f) (II) NOTWITHSTANDING THE REQUIREMENTS OF SUBSECTION  
35 (2)(f)(I) OF THIS SECTION, THE FIRST APPOINTED MEMBERS SHALL SERVE  
36 INITIAL TERMS OF TWO-YEARS FOR FOUR MEMBERS, THREE-YEARS FOR  
37 ANOTHER FOUR MEMBERS, AND FOUR-YEARS FOR THE REMAINING FIVE  
38 MEMBERS. THIS SUBSECTION (2)(f)(II) IS REPEALED ON JULY 1, 2028."

1 Reletter succeeding paragraph accordingly.
