

HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on Appropriations.

SB22-232 be amended as follows:

1 Amend reengrossed bill, page 8, strike lines 14 and 15 and substitute "BY
2 THE GOVERNOR FOR MISCONDUCT, INCOMPETENCE, NEGLECT OF DUTY, OR
3 OTHER CAUSE.".

4 Page 8, strike lines 16 through 18 and insert:

5 "(3) THE GOVERNOR SHALL MAKE INITIAL APPOINTMENTS OF
6 BOARD MEMBERS IN ACCORDANCE WITH SUBSECTION (2)(b) OF THIS
7 SECTION ON OR BEFORE SEPTEMBER 1, 2022, AND SHALL APPOINT ONE OF
8 THE MEMBERS TO SERVE AS THE INITIAL CHAIRPERSON. THE INITIAL
9 CHAIRPERSON HAS THE AUTHORITY TO ESTABLISH AND ADMINISTER
10 MATTERS RELATED TO THE INITIAL SET UP OF THE AUTHORITY, INCLUDING
11 STAFFING, LEGAL SERVICES, OR TO COORDINATE WITH THE OFFICE OF
12 ECONOMIC DEVELOPMENT, CREATED IN SECTION 24-48.5-101 (1), OR THE
13 DEPARTMENT OF LOCAL AFFAIRS, CREATED IN SECTION 24-1-125 (1), ON
14 ADMINISTRATIVE MATTERS AND OTHER MATTERS RELATED TO THE INITIAL
15 SET UP AND OPERATION OF THE AUTHORITY, WHICH CONTRACTS SHALL BE
16 FOR A TERM OF NO LONGER THAN ONE YEAR FROM SEPTEMBER 1, 2022,
17 AND SHALL BE RATIFIED BY THE BOARD AT ITS INITIAL MEETING SET FORTH
18 IN SUBSECTION (4)(a) OF THIS SECTION. THE AUTHORITY MAY HIRE STAFF
19 AS IT DEEMS NECESSARY OR CONVENIENT TO ADMINISTER THIS PART 11
20 AND THE OFFICE OF ECONOMIC DEVELOPMENT OR THE DEPARTMENT OF
21 LOCAL AFFAIRS MAY ASSIST THE AUTHORITY WITH ADMINISTERING THIS
22 PART 11. THE AUTHORITY MAY COOPERATE AND ENTER INTO CONTRACTS
23 WITH THE OFFICE OF ECONOMIC DEVELOPMENT OR THE DEPARTMENT OF
24 LOCAL AFFAIRS, OR WITH ANOTHER AGENCY OR ENTITY, FOR
25 ADMINISTRATIVE OR OPERATIONS MATTERS, INCLUDING FOR STAFFING.
26 THE AUTHORITY SHALL PAY THE OFFICE OF ECONOMIC DEVELOPMENT, THE
27 DEPARTMENT OF LOCAL GOVERNMENT, OR ANOTHER AGENCY OR ENTITY
28 THAT THE AUTHORITY HAS ENTERED INTO A CONTRACT WITH FOR ALL
29 COSTS INCURRED FOR SERVICES, STAFFING, AND ADMINISTRATIVE COSTS
30 THAT ARE APPROVED BY THE INITIAL CHAIRPERSON AND RATIFIED BY THE
31 BOARD OR THAT ARE APPROVED BY THE AUTHORITY.

32 (4) (a) WITHIN THIRTY DAYS OF THE GOVERNOR'S INITIAL
33 APPOINTMENTS PURSUANT TO SUBSECTIONS(2) AND (3) OF THIS SECTION,
34 THE INITIAL CHAIRPERSON OF THE BOARD AS DESIGNATED BY THE
35 GOVERNOR SHALL SET DATES FOR THE FIRST AND SECOND BOARD
36 MEETINGS WHICH MUST BE HELD BEFORE DECEMBER 31, 2022. THE BOARD
37 MAY ELECT A NEW CHAIRPERSON PURSUANT TO SECTION 29-4-1105 (1)(n)
38 AT EITHER INITIAL MEETING. SUBSEQUENT MEETINGS SHALL BE SET BY THE
39 CHAIRPERSON OF THE BOARD.".

- 1 Renumber succeeding subsections accordingly.
- 2 Page 9, strike line 24 and substitute "ANY CONTRACT, TRANSACTION, OR
3 PROPOSAL WITH THE AUTHORITY OR ANY INTEREST, DIRECT OR INDIRECT,
4 IN A NONPROFIT OR FOR-PROFIT ORGANIZATION SUBMITTING A PROPOSAL
5 TO THE AUTHORITY SHALL DISCLOSE".
- 6 Page 15, line 25, strike "11." and substitute "11; AND
7 (r) OTHER POWERS NECESSARY TO ACCOMPLISH THE AUTHORITY'S
8 SPECIFIC GOALS AS REQUIRED UNDER THIS PART 11.".
- 9 Page 18, line 21, strike "29-4-1104 (11)(a)." and substitute "29-4-1104
10 (12)(a)".
- 11 Page 18, line 23, strike "OCTOBER 1, 2022," and substitute "APRIL 1,
12 2023,".
- 13 Page 18, line 26, strike "JANUARY 1, 2023," and substitute "JULY 1,
14 2023,".
