

## HOUSE FLOOR AMENDMENT

Second Reading

1 Amend reengrossed bill, page 12, strike line 21 and substitute "(1)(a) and  
2 (1)(c); and **amend as amended by Senate Bill 22-013** (1)(b) as  
3 follows:".

4 Page 13, strike lines 2 through 21 and substitute:

5 "(b) (I) EXCEPT AS PROVIDED IN SUBSECTION (1)(b)(II) OF THIS  
6 SECTION, the board consists of seven dentist members, three dental  
7 hygienist members, and three members from the public at large. The  
8 governor shall appoint each member for a term of four years, and each  
9 member must have the qualifications provided in this article 220. A  
10 member shall not serve more than two consecutive terms of four years.  
11 Each board member holds office until the member's term expires or until  
12 the governor appoints a successor. THIS SUBSECTION (1)(b)(I) IS  
13 REPEALED, EFFECTIVE DECEMBER 1, 2031.

14 (II) (A) EFFECTIVE JULY 1, 2031, THE BOARD CONSISTS OF SEVEN  
15 DENTIST MEMBERS, TWO DENTAL THERAPIST MEMBERS, TWO DENTAL  
16 HYGIENIST MEMBERS, AND TWO MEMBERS FROM THE PUBLIC AT LARGE.  
17 THE GOVERNOR SHALL APPOINT EACH MEMBER FOR A TERM OF FOUR  
18 YEARS, AND EACH MEMBER MUST HAVE THE QUALIFICATIONS PROVIDED  
19 IN THIS ARTICLE 220. A MEMBER SHALL NOT SERVE MORE THAN TWO  
20 CONSECUTIVE TERMS OF FOUR YEARS. EACH BOARD MEMBER HOLDS  
21 OFFICE UNTIL THE MEMBER'S TERM EXPIRES OR UNTIL THE GOVERNOR  
22 APPOINTS A SUCCESSOR.

23 (B) A MEMBER SERVING ON THE BOARD AS OF JUNE 30, 2031, MAY  
24 SERVE THE MEMBER'S FULL TERM.

25 ~~(H)~~ (III) A person is qualified to be appointed to the board if the  
26 person:

27 (A) Is a legal resident of Colorado;

28 (B) Is currently licensed as a dentist, DENTAL THERAPIST, or dental  
29 hygienist, if fulfilling that position on the board; and

30 (C) Has been actively engaged in a clinical practice in this state  
31 for at least five years immediately preceding the appointment, if fulfilling  
32 the position of dentist, DENTAL THERAPIST, or dental hygienist on the  
33 board.".

34 Page 14, strike lines 13 through 19.
