

SENATE COMMITTEE OF REFERENCE AMENDMENT

Committee on Health & Human Services.

SB22-219 be amended as follows:

1 Amend printed bill, page 8, strike lines 8 through 14 and substitute
2 **"requirement - rules. (1) (a) A DENTAL THERAPIST MAY PERFORM THE**
3 **FOLLOWING TASKS AND PROCEDURES UNDER THE DIRECT SUPERVISION OF**
4 **A LICENSED DENTIST:**

5 (I) PREPARE AND PLACE DIRECT RESTORATION IN PRIMARY AND
6 PERMANENT TEETH;

7 (II) PERFORM BRUSH BIOPSIES;

8 (III) EXTRACT PERIODONTALLY DISEASED PERMANENT TEETH WITH
9 MOBILITY OF +3 TO +4, EXCEPT FOR TEETH THAT ARE UNERUPTED,
10 IMPACTED, FRACTURED, OR REQUIRE SECTIONING;

11 (IV) EXTRACT BABY TEETH THAT ARE ERUPTED OR NOT IMPACTED
12 WITH RADIOLOGICAL EVIDENCE OF ROOTS;

13 (V) ORAL EXAMINATION, EVALUATION, DIAGNOSIS, AND
14 TREATMENT PLANNING FOR CONDITIONS AND SERVICES THAT ARE WITHIN
15 THE DENTAL THERAPIST'S SCOPE OF PRACTICE AND EDUCATION;

16 (VI) PLACE TEMPORARY CROWNS;

17 (VII) PREPARE AND PLACE PREFORMED CROWNS; AND

18 (VIII) REPAIR DEFECTIVE PROSTHETIC DEVICES.

19 (b) A DENTAL THERAPIST LICENSED PURSUANT TO THIS ARTICLE
20 220 WHO HAS COMPLETED ONE THOUSAND HOURS OR MORE UNDER DIRECT
21 SUPERVISION, OR WHO HAS COMPLETED THE DIRECT SUPERVISION HOURS
22 REQUIRED UNDER THE WAIVER DESCRIBED IN SUBSECTION (1)(e) OF THIS
23 SECTION, MAY PRACTICE THE TASKS AND PROCEDURES IDENTIFIED IN
24 SUBSECTION (1)(a) OF THIS SECTION UNDER THE INDIRECT SUPERVISION OF
25 A LICENSED DENTIST PURSUANT TO A WRITTEN ARTICULATED PLAN WITH
26 THE DENTIST THAT MEETS THE REQUIREMENTS OF SUBSECTION (2) OF THIS
27 SECTION.

28 (c) A DENTAL THERAPIST LICENSED PURSUANT TO THIS ARTICLE".

29 Page 9, after line 6 insert:

30 "(d) A DENTAL THERAPIST SHALL COMPLETE AT LEAST A MAJORITY
31 OF THE DIRECT SUPERVISION HOURS REQUIRED UNDER SUBSECTION (1)(b)
32 OR (1)(e) PERFORMING THE TASKS AND PROCEDURES IDENTIFIED IN
33 SUBSECTION (1)(a) OF THIS SECTION."

34 Page 9, line 7, strike "(c)" and substitute "(e)".
