HB22-1269 be amended as follows:

1 Amend printed bill, page 3, after line 17 insert:

2 "(III) IF THE PERSON OFFERS A PLAN OR ARRANGEMENT IN OTHER
3 STATES, THE TOTAL NUMBER OF PARTICIPANTS IN THE PLAN OR
4 ARRANGEMENT NATIONALLY;

5 (IV) ANY CONTRACTS THE PERSON HAS ENTERED INTO WITH
6 PROVIDERS THAT PROVIDE HEALTH-CARE SERVICES TO PLAN OR
7 ARRANGEMENT PARTICIPANTS;".

8 Renumber succeeding subparagraphs accordingly.

9 Page 3, after line 23 insert:

10 "(VI) THE TOTAL DOLLAR AMOUNT OF CLAIMS OR REQUESTS FOR
11 PAYMENT OR COVERAGE OF HEALTH-CARE COSTS OR SERVICES SUBMITTED
12 IN THE IMMEDIATELY PRECEDING CALENDAR YEAR BY PARTICIPANTS IN
13 THE PLAN OR ARRANGEMENT OR PROVIDERS THAT PROVIDED
14 HEALTH-CARE SERVICES TO PLAN OR ARRANGEMENT PARTICIPANTS;

15 (VII) THE TOTAL DOLLAR AMOUNT OF CLAIMS OR REQUESTS FOR
16 PAYMENT OR COVERAGE OF HEALTH-CARE COSTS OR SERVICES THAT WERE
17 DETERMINED TO QUALIFY FOR PAYMENT OR COVERAGE UNDER THE PLAN
18 OR ARRANGEMENT IN THE IMMEDIATELY PRECEDING CALENDAR YEAR;".

19 Renumber succeeding subparagraphs accordingly.

20 Page 4, after line 4 insert:

21 "(X) THE TOTAL NUMBER OF CLAIMS OR REQUESTS FOR PAYMENT
22 OR COVERAGE OF HEALTH-CARE COSTS OR SERVICES SUBMITTED IN THE
23 IMMEDIATELY PRECEDING CALENDAR YEAR THAT WERE DENIED,
24 EXPRESSED AS A PERCENTAGE OF TOTAL CLAIMS OR REQUESTS SUBMITTED
25 IN THAT CALENDAR YEAR, AND THE TOTAL NUMBER OF CLAIM OR REQUEST
26 DENIALS THAT WERE APPEALED;

27 (XI) THE TOTAL AMOUNT OF HEALTH-CARE EXPENSES SUBMITTED
28 BY PLAN OR ARRANGEMENT PARTICIPANTS OR PROVIDERS IN THE
29 IMMEDIATELY PRECEDING CALENDAR YEAR THAT QUALIFY FOR PAYMENT
30 OR COVERAGE PURSUANT TO THE PLAN OR ARRANGEMENT CRITERIA BUT
31 THAT, AS OF THE END OF THAT CALENDAR YEAR, HAVE NOT BEEN PAID OR
32 COVERED, EXCLUDING ANY AMOUNTS THAT THE PLAN OR ARRANGEMENT
33 PARTICIPANTS INCURRING THE HEALTH-CARE COSTS MUST PAY BEFORE
34 RECEIVING PAYMENTS OR COVERAGE UNDER THE PLAN OR

- 1 ARRANGEMENT;".
- 2 Renumber succeeding subparagraphs accordingly.
- 3 Page 5, line 9, after "YEARS;" add "AND".
- 4 Page 5, strike lines 12 through 16.
