Committee on Health & Insurance.

HB22-1269 be amended as follows:

- 1 Amend printed bill, page 3, line 1, after "(1)" insert "(a)".
- 2 Page 3, line 7, strike "SUBMIT TO THE COMMISSIONER" and substitute
- 3 "POST THE FOLLOWING INFORMATION AND MATERIALS ON A SINGLE WEB
- 4 PAGE ON ITS PUBLICLY ACCESSIBLE WEBSITE AND SUBMIT TO THE
- 5 COMMISSIONER A LINK TO THE WEB PAGE".
- 6 Page 3, strike lines 9 through 27.
- 7 Strike page 4.
- 8 Page 5, strike lines 1 through 16 and substitute:
  - 9 "(I) THE NAME OF THE PERSON'S CHIEF EXECUTIVE OFFICER, AND
  - 10 IF DIFFERENT, THE NAME OF AN INDIVIDUAL SERVING AS A KEY CONTACT
  - 11 FOR THE PERSON, AS WELL AS A MAILING ADDRESS, E-MAIL ADDRESS, AND
  - 12 TELEPHONE NUMBER THAT CAN BE USED TO CONTACT THE OFFICER OR
  - 13 INDIVIDUAL, AND THE ORGANIZATION'S WEB ADDRESS FOR GENERAL
  - 14 INQUIRIES;
  - 15 (II) COPIES OF ALL NEW PARTICIPANT APPLICATION FORMS AND
  - 16 GUIDELINES USED BY THE PERSON FOR THE PLAN OR ARRANGEMENT IN THE
  - 17 PRIOR CALENDAR YEAR;
  - 18 (III) A COPY OF THE PERSON'S MOST RECENT AUDITED ANNUAL
  - 19 FINANCIAL STATEMENTS FOR THE PRIOR CALENDAR YEAR;
  - 20 (IV) THE TOTAL NUMBER OF PARTICIPANTS IN THE PERSON'S PLAN
  - 21 OR ARRANGEMENT WHO ARE RESIDENTS OF THIS STATE AS OF THE END OF
  - 22 THE PRIOR CALENDAR YEAR; AND
  - 23 (V) IF THE PERSON IS DESCRIBED IN 26 U.S.C. SEC. 501 (c)(3), AS
  - 24 AMENDED, A STATEMENT INDICATING WHETHER OR NOT THE PERSON HAS
  - 25 ENGAGED IN ANY EXCESS BENEFIT TRANSACTION, AS DEFINED IN 26 U.S.C.
  - 26 SEC. 4958 (c)(1), AS AMENDED."
