

HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on State, Civic, Military, & Veterans Affairs.

HB22-1084 be amended as follows:

1 Amend printed bill, strike everything below the enacting clause and  
2 substitute:

3 "SECTION 1. In Colorado Revised Statutes, 1-2-302.5, **amend**  
4 (2)(a), (2)(b) introductory portion, (2)(b)(I)(A), (2)(b)(III) introductory  
5 portion, (2)(c), and (4); and **add** (1.5) and (6) as follows:

6 **1-2-302.5. Change of address search - ineligible juror list -**  
7 **rules.** (1.5) AS SOON AS PRACTICABLE AFTER THE END OF EACH MONTH,  
8 THE STATE COURT ADMINISTRATOR SHALL FURNISH THE SECRETARY OF  
9 STATE WITH A REPORT OF ALL PERSONS WHO REPORT AS INELIGIBLE TO  
10 SERVE AS A TRIAL OR GRAND JUROR BECAUSE THEY ARE EITHER NOT A  
11 CITIZEN OR DO NOT RESIDE IN THE COUNTY IN WHICH THEY ARE  
12 SUMMONED FOR JUROR SERVICE.

13 (2) (a) The secretary of state shall transmit monthly to the  
14 appropriate county clerk and recorders the data obtained from the search  
15 conducted under subsection (1) of this section AND THE INFORMATION  
16 RECEIVED FROM THE STATE COURT ADMINISTRATOR PURSUANT TO  
17 SUBSECTION (1.5) OF THIS SECTION.

18 (b) If any search of the national change of address database  
19 administered by the United States postal service conducted under  
20 SUBSECTION (1) OF this section, OR THE INELIGIBLE JUROR INFORMATION  
21 REPORT RECEIVED FROM THE STATE COURT ADMINISTRATOR PURSUANT TO  
22 SUBSECTION (1.5) OF THIS SECTION, indicates an elector has permanently  
23 moved, the county clerk and recorder shall act as follows:

24 (I) (A) If the search OR INELIGIBLE JUROR INFORMATION REPORT  
25 indicates that the elector moved within the state, the county clerk and  
26 recorder of the county in which the elector's new address is located shall  
27 mark the elector's registration record as "Active" and update the elector's  
28 registration record with the elector's new address and send, to the elector's  
29 old address, notice of the change by forwardable mail and a postage  
30 pre-paid pre-addressed return form by which the registrant may verify or  
31 correct the address information.

32 (III) If the search OR INELIGIBLE JUROR INFORMATION REPORT  
33 indicates that the elector moved to a different state, the county clerk and  
34 recorder shall mark the elector's registration record "Inactive" and send  
35 a confirmation card and:

36 (c) A county clerk and recorder shall make corrections to address  
37 updates made pursuant to a national change of address search  
38 CONDUCTED UNDER SUBSECTION (1) OF THIS SECTION OR THE  
39 INFORMATION RECEIVED FROM THE STATE COURT ADMINISTRATOR

1 PURSUANT TO SUBSECTION (1.5) OF THIS SECTION upon receiving  
2 additional information from the elector.

3 (4) If any search conducted pursuant to SUBSECTION (1) OF this  
4 section OR INELIGIBLE JUROR INFORMATION REPORT COMPILED PURSUANT  
5 TO SUBSECTION (1.5) OF THIS SECTION indicates that an elector has added  
6 or changed a post office box, the county clerk and recorder shall update  
7 the elector's registration record with the new post office box as the  
8 elector's mailing address and send ~~him or her~~ the elector a confirmation  
9 card in accordance with section 1-2-605. The card must notify the elector  
10 of the change in mailing address and apprise the elector of ~~his or her~~ the  
11 elector's place of residence for voting purposes.

12 (6) A COUNTY CLERK AND RECORDER SHALL FILE A WRITTEN  
13 CHALLENGE, IN ACCORDANCE WITH THE PROCESS ESTABLISHED IN SECTION  
14 1-9-101, CHALLENGING THE REGISTRATION OF ANY ELECTOR WHO THE  
15 INELIGIBLE JUROR INFORMATION REPORT RECEIVED FROM THE STATE  
16 COURT ADMINISTRATOR PURSUANT TO SUBSECTION (1.5) OF THIS SECTION  
17 SUGGESTS IS NOT A CITIZEN.

18 **SECTION 2. Safety clause.** The general assembly hereby finds,  
19 determines, and declares that this act is necessary for the immediate  
20 preservation of the public peace, health, or safety."

21 Page 1, strike lines 102 through 109 and substitute "CERTAIN INELIGIBLE  
22 JURORS."
