

HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on Transportation & Local Government.

HB22-1388 be amended as follows:

1 Amend printed bill, page 5, after line 13, insert:

2 **"SECTION 6.** In Colorado Revised Statutes, **add** 42-3-261 as
3 follows:

4 **42-3-261. Special plates - one hundred fiftieth anniversary.**

5 (1) BEGINNING ON OR AFTER AUGUST 1, 2023, AND BEFORE AUGUST 1,
6 2027, THE DEPARTMENT SHALL ISSUE SPECIAL LICENSE PLATES TO
7 QUALIFIED APPLICANTS IN ACCORDANCE WITH THIS SECTION FOR
8 MOTORCYCLES, PASSENGER CARS, TRUCKS, OR NONCOMMERCIAL OR
9 RECREATIONAL MOTOR VEHICLES THAT DO NOT EXCEED SIXTEEN
10 THOUSAND POUNDS EMPTY WEIGHT.

11 (2)(a) THERE IS HEREBY ESTABLISHED THE ONE HUNDRED FIFTIETH
12 ANNIVERSARY OF STATEHOOD LICENSE PLATE.

13 (b) THE DEPARTMENT SHALL HOLD A COMPETITION TO DESIGN A
14 SPECIAL LICENSE PLATE TO COMMEMORATE THE ONE HUNDRED FIFTIETH
15 ANNIVERSARY OF COLORADO BECOMING A STATE. THE DEPARTMENT
16 SHALL CLOSE THE COMPETITION BY FEBRUARY 1, 2023, AND CHOOSE A
17 DESIGN BY MARCH 1, 2023.

18 (c) A PERSON MAY APPLY FOR A ONE HUNDRED FIFTIETH
19 ANNIVERSARY OF STATEHOOD LICENSE PLATE IF THE PERSON PAYS THE
20 TAXES AND FEES REQUIRED UNDER THIS SECTION.

21 (3) THE AMOUNT OF THE TAXES AND FEES FOR SPECIAL LICENSE
22 PLATES UNDER THIS SECTION IS THE SAME AS THE AMOUNT OF THE TAXES
23 AND FEES FOR REGULAR MOTOR VEHICLE LICENSE PLATES.

24 (4) A QUALIFIED APPLICANT MAY APPLY TO THE DEPARTMENT FOR
25 PERSONALIZED ONE HUNDRED FIFTIETH ANNIVERSARY OF STATEHOOD
26 LICENSE PLATES. UPON PAYMENT OF THE ADDITIONAL FEE REQUIRED BY
27 SECTION 42-3-211 (6)(a) FOR PERSONALIZED LICENSE PLATES, THE
28 DEPARTMENT MAY ISSUE THE PLATES IF THE QUALIFIED APPLICANT
29 COMPLIES WITH SECTION 42-3-211. IF A QUALIFIED APPLICANT HAS
30 EXISTING PERSONALIZED LICENSE PLATES FOR A MOTOR VEHICLE, THE
31 APPLICANT MAY TRANSFER THE COMBINATION OF LETTERS OR NUMBERS
32 TO A NEW SET OF ONE HUNDRED FIFTIETH ANNIVERSARY OF STATEHOOD
33 LICENSE PLATES FOR THE VEHICLE UPON PAYING THE FEE REQUIRED BY
34 SECTION 42-3-211 (6)(a) AND UPON TURNING IN THE EXISTING PLATES TO
35 THE DEPARTMENT. A PERSON WHO HAS OBTAINED PERSONALIZED LICENSE
36 PLATES UNDER THIS SUBSECTION (6) MUST PAY THE ANNUAL FEE IMPOSED
37 BY SECTION 42-3-211 (6)(b) FOR RENEWAL OF THE PERSONALIZED PLATES.
38 THE FEES UNDER THIS SUBSECTION (6) ARE IN ADDITION TO ALL OTHER
39 APPLICABLE TAXES AND FEES.".

40 Renumber succeeding sections accordingly.
