SB22-183 be amended as follows:

1 Amend reengrossed bill, page 11, after line 16 insert:

2 "(d) THE STATE DEPARTMENT SHALL ANNUALLY PUBLISH ON ITS
3 WEBSITE:

4 (I) FOR EACH ORGANIZATION THAT RECEIVES FUNDING PURSUANT
5 TO THIS ARTICLE 7.5, THE NAME OF THE ORGANIZATION, AMOUNT OF THE
6 FUNDING RECEIVED, THE NUMBER AND TYPES OF CRIMES FOR WHICH
7 VICTIMS ARE SERVED, AND THE SERVICES PROVIDED WITH THE FUNDING;

8 (II) THE FOLLOWING INFORMATION FROM ORGANIZATIONS THAT
9 RECEIVE FUNDING, IN AGGREGATE: THE NUMBER AND TYPES OF CRIMES
10 FOR WHICH VICTIMS ARE SERVED; THE TYPES OF SERVICES PROVIDED; AND
11 THE GENDER, RACE AND ETHNICITY, AND OTHER AVAILABLE DEMOGRAPHIC
12 INFORMATION OF CLIENTS SERVED WITH THE FUNDING; AND

13 (III) TO THE EXTENT KNOWN, AND IN AGGREGATE FORM, THE
14 GENDER, RACIAL AND ETHNIC MAKEUP, AND OTHER DEMOGRAPHIC
15 INFORMATION OF THE STAFF AND BOARD OF DIRECTORS, IF APPLICABLE, OF
16 ORGANIZATIONS THAT RECEIVE FUNDING. THE STATE DEPARTMENT SHALL
17 MAKE ITS BEST EFFORT TO COLLECT THE INFORMATION DESCRIBED IN THIS
18 SUBSECTION (4)(d)(III).".

19 Reletter succeeding paragraph accordingly.

20 Page 12, after line 25, insert:

21 "(5) THE DIVISION SHALL ANNUALLY PUBLISH ON ITS WEBSITE:

22 (a) FOR EACH ORGANIZATION THAT RECEIVES A GRANT, THE NAME
23 OF THE ORGANIZATION, AMOUNT OF THE GRANT AWARD, THE NUMBER AND
24 TYPES OF CRIMES FOR WHICH VICTIMS ARE SERVED, AND THE SERVICES
25 PROVIDED WITH GRANT MONEY;

26 (b) THE FOLLOWING INFORMATION FROM ORGANIZATIONS THAT
27 RECEIVE A GRANT, IN AGGREGATE: THE NUMBER AND TYPES OF CRIMES
28 FOR WHICH VICTIMS ARE SERVED; THE TYPES OF SERVICES PROVIDED; AND
29 THE GENDER, RACE AND ETHNICITY, AND OTHER AVAILABLE DEMOGRAPHIC
30 INFORMATION OF CLIENTS SERVED WITH A GRANT AWARD; AND

31 (c) TO THE EXTENT KNOWN, AND IN AGGREGATE FORM, THE
32 GENDER, RACIAL AND ETHNIC MAKEUP, AND OTHER DEMOGRAPHIC
33 INFORMATION OF THE STAFF AND BOARD OF DIRECTORS, IF APPLICABLE, OF
34 ORGANIZATIONS THAT RECEIVE A GRANT. THE DIVISION SHALL MAKE ITS
35 BEST EFFORT TO COLLECT THE INFORMATION DESCRIBED IN THIS
36 SUBSECTION (5).".
