HB22-1372 be amended as follows:

- 1 Amend printed bill, page 4, line 5, after "EMERGENCY" insert "EVENT".
- 2 Page 4, line 9, strike "AND".
- 3 Page 4, line 10, strike "EXECUTING." and substitute "EXECUTING; AND
- 4 (V) CREATION OF AN EXEMPTION FOR EMERGENCY STATIONARY
- 5 ENGINE USE AT MILITARY INSTALLATIONS REQUIRES A CHANGE TO
- 6 COLORADO'S STATE IMPLEMENTATION PLAN, WHICH MUST BE APPROVED
- 7 BY THE ADMINISTRATOR OF THE FEDERAL ENVIRONMENTAL PROTECTION
- 8 AGENCY."
- 9 Page 5, line 4, after "ENGINE" insert "AT MILITARY FACILITIES OR
- 10 FACILITIES UNDER THE CONTROL OF THE UNITED STATES DEPARTMENT OF
- 11 DEFENSE".
- 12 Page 5, line 10, strike "OPERATING" and substitute "COMMENCING
- 13 OPERATION OF".
- 14 Page 5, line 19, strike "CORRECT OR MITIGATE" and substitute "MITIGATE
- 15 THE USE OF THE EMERGENCY STATIONARY ENGINE DURING".
- 16 Page 6, line 2, after "ENGINE" insert "AT MILITARY FACILITIES OR
- 17 FACILITIES UNDER THE CONTROL OF THE UNITED STATES DEPARTMENT OF
- 18 DEFENSE".
- 19 Page 6, line 17, strike "DIVISION." and substitute "DIVISION FOR
- 20 EMERGENCY STATIONARY ENGINES FOR MILITARY FACILITIES OR
- 21 FACILITIES UNDER THE CONTROL OF THE UNITED STATES DEPARTMENT OF
- 22 DEFENSE.
- 23 (6) (a) NO LATER THAN SEPTEMBER 1, 2022, THE GOVERNOR OR
- 24 THE GOVERNOR'S DESIGNEE SHALL SUBMIT THIS SECTION TO THE
- 25 ADMINISTRATOR FOR INCLUSION IN COLORADO'S STATE IMPLEMENTATION
- 26 PLAN.
- 27 (b) THIS SECTION WILL TAKE EFFECT ONLY IF THE ADMINISTRATOR
- 28 APPROVES THIS SECTION'S INCLUSION IN THE STATE IMPLEMENTATION
- 29 PLAN. THE DIVISION SHALL NOTIFY THE REVISOR OF STATUTES IN WRITING
- 30 OF THE DATE ON WHICH THE CONDITION SPECIFIED IN THIS SUBSECTION
- 31 (6)(b) HAS OCCURRED BY E-MAILING THE NOTICE TO
- 32 REVISOROFSTATUTES.GA@STATE.CO.US. THIS SECTION TAKES EFFECT ON
- 33 THE EFFECTIVE DATE IDENTIFIED IN THE NOTICE THAT THE ADMINISTRATOR
- 34 APPROVED THIS SECTION'S INCLUSION IN COLORADO'S STATE

1 IMPLEMENTATION PLAN OR, IF THE NOTICE DOES NOT SPECIFY THAT DATE,
2 UPON THE DATE OF THE NOTICE TO THE REVISOR OF STATUTES.

3 (7) IF THE ADMINISTRATOR FAILS TO APPROVE INCLUSION OF THIS
4 SECTION INTO COLORADO'S STATE IMPLEMENTATION PLAN BY SEPTEMBER
5 1, 2025:

6 (a) THIS SECTION IS REPEALED, EFFECTIVE OCTOBER 1, 2025; AND

7 (b) THE GOVERNOR OR THE GOVERNOR'S DESIGNEE SHALL
8 WITHDRAW THIS SECTION AS A STATE IMPLEMENTATION PLAN REVISION."
