Second Reading

1 Amend printed bill, page 7, strike lines 4 and 5 and substitute "THIS
2 SECTION, OF THE THIRTY PERCENT OF A TEACHER'S OR PRINCIPAL'S
3 EVALUATION THAT IS BASED ON STUDENT ACADEMIC GROWTH, UP TO TEN
4 PERCENT MAY BE BASED ON MEASURES OF COLLECTIVE STUDENT
5 ACADEMIC GROWTH THAT ARE BASED ON THE".

6 Page 7, line 7, strike "LICENSED PERSON" and substitute "TEACHER OR
7 PRINCIPAL".

8 Page 7, line 9, strike "LICENSED PERSON" and substitute "TEACHER OR
9 PRINCIPAL", and strike "LICENSED PERSON'S" and substitute "TEACHER'S
10 OR PRINCIPAL'S".

11 Page 7, line 10, strike "COLLECTIVE MEASURES" and substitute
12 "MEASURES OF COLLECTIVE STUDENT ACADEMIC GROWTH".

13 Page 7, line 12, strike "LICENSED PERSON" and substitute "TEACHER OR
14 PRINCIPAL".

15 Page 7, strike lines 15 through 17 and substitute "FOR ONE SCHOOL YEAR
16 OR LESS MUST NOT INCLUDE DATA THAT WAS CREATED PRIOR TO THE DATE
17 ON WHICH THE LICENSED PERSON COMMENCED EMPLOYMENT WITH THE
18 SCHOOL DISTRICT OR BOARD OF COOPERATIVE SERVICES.".

19 Page 7, line 21, strike "(7) introductory portion, and (9);" and substitute
20 "and (7) introductory portion;".

21 Page 10, strike lines 20 through 22 and substitute "2023-24 SCHOOL YEAR
22 AND SCHOOL YEARS THEREAFTER, OF THE THIRTY PERCENT OF A
23 TEACHER'S EVALUATION THAT IS BASED ON STUDENT ACADEMIC GROWTH,
24 UP TO TEN PERCENT MAY BE BASED ON MEASURES OF COLLECTIVE
25 STUDENT ACADEMIC GROWTH THAT ARE BASED ON THE PERFORMANCE OF
26 ALL".

27 Page 10, line 24, strike "LICENSED PERSON" and substitute "TEACHER".

28 Page 10, strike lines 25 through 27 and substitute "ALL STUDENTS
29 ENROLLED IN THE SCHOOL IN WHICH THE TEACHER IS EMPLOYED, BUT A
30 TEACHER'S EVALUATION MUST NOT INCLUDE MEASURES OF COLLECTIVE
31 STUDENT ACADEMIC GROWTH THAT ARE BASED ON THE PERFORMANCE
32 OF".

- 1 Page 11, line 2, strike "LICENSED PERSON" and substitute "TEACHER".
- 2 Page 11, strike lines 7 and 8 and substitute "YEAR OR LESS MUST NOT
3 INCLUDE DATA THAT WAS CREATED PRIOR TO THE DATE ON WHICH THE
4 LICENSED PERSON COMMENCED EMPLOYMENT WITH THE SCHOOL DISTRICT
5 OR BOARD OF COOPERATIVE SERVICES.".
- 6 Page 11, line 13, strike "LICENSED PERSONNEL," and substitute "SCHOOL
7 DISTRICT PERSONNEL PERFORMANCE EVALUATION COUNCILS,".
- 8 Page 11, line 16, strike "RECORDING." and substitute "RECORDING; AND A
9 PEER ASSISTANCE AND REVIEW MODEL THAT ALLOWS LICENSED
10 PERSONNEL TO BE EVALUATED BY PEERS WHO ARE LICENSED IN THE SAME
11 FIELD AS THE LICENSED PERSON BEING EVALUATED AND, IF FEASIBLE,
12 HAVE MORE THAN ONE YEAR OF EXPERIENCE.".
- 13 Page 13, strike line 15 and substitute "PERFORMANCE RATINGS FOR ALL
14 LICENSED PERSONNEL WHO WERE EVALUATED TO THE DEPARTMENT NO
15 LATER THAN OCTOBER 15 OF".
- 16 Page 15, strike lines 5 through 19.
