

## SENATE FLOOR AMENDMENT

Second Reading

BY SENATOR Lundeen

1 Amend printed bill, page 7, strike line 22 and substitute "(1)(e)(III),  
2 (1)(e)(IV), and (10) as follows:".

3 Page 7, line 24, after "**rules**" insert "**- report**".

4 Page 15, after line 19, insert:

5 "(10)(a) FOR LICENSED PERSONNEL EVALUATIONS COMPLETED FOR  
6 THE 2022-23 SCHOOL YEAR AND FOR EACH SCHOOL YEAR THEREAFTER,  
7 EACH SCHOOL DISTRICT AND BOARD OF COOPERATIVE SERVICES SHALL  
8 PREPARE A REPORT OF THE EFFECTIVENESS RATINGS ASSIGNED BASED ON  
9 THE EVALUATIONS COMPLETED FOR THE APPLICABLE SCHOOL YEAR AND  
10 THE ACTIONS RECOMMENDED, BASED ON OR IN RESPONSE TO THE  
11 EVALUATIONS, TO IMPROVE OR MAINTAIN THE EFFECTIVENESS OF  
12 LICENSED PERSONNEL. THE REPORT MUST NOT INCLUDE PERSONALLY  
13 IDENTIFYING INFORMATION WITH REGARD TO ANY LICENSED PERSON. THE  
14 SCHOOL DISTRICT OR BOARD OF COOPERATIVE SERVICES SHALL SUBMIT  
15 THE REPORT TO THE DEPARTMENT NO LATER THAN OCTOBER 1 OF THE  
16 SCHOOL YEAR FOLLOWING THE SCHOOL YEAR FOR WHICH THE  
17 EVALUATIONS WERE COMPLETED. NO LATER THAN JANUARY 15  
18 IMMEDIATELY FOLLOWING RECEIPT OF THE REPORTS, THE DEPARTMENT  
19 SHALL SUBMIT A COMPILATION OF THE REPORTS TO THE STATE BOARD AND  
20 TO THE EDUCATION COMMITTEES OF THE SENATE AND THE HOUSE OF  
21 REPRESENTATIVES, OR ANY SUCCESSOR COMMITTEES, AND SHALL POST A  
22 COPY OF THE COMPILATION TO THE DEPARTMENT WEBSITE.

23 (b) NOTWITHSTANDING THE REQUIREMENT IN SECTION 24-1-136  
24 (11)(a)(I), THE REQUIREMENT TO SUBMIT THE COMPILATION OF REPORTS  
25 SPECIFIED IN SUBSECTION (10)(a) OF THIS SECTION CONTINUES  
26 INDEFINITELY.
