- 8 Page 2, line 1, strike "CARRIER." and substitute "CARRIER; AND
9 SUBMITTED AT LEAST TWENTY-FOUR PRIOR AUTHORIZATION REQUESTS
10 FOR THE SAME HEALTH-CARE SERVICE FOR COVERED PERSONS UNDER A
11 HEALTH BENEFIT PLAN OFFERED BY THE CARRIER."..
- 12 Page 2, strike line 15 and substitute "OF THE PROVIDER'S STATUS AS A
13 QUALIFIED PROVIDER AND PROVIDE ALL OF".
- 14 Page 2, line 16, after "ITS" insert "INITIAL EXAMINATION OR".
- 15 Page 2, line 18, strike "REVIEW."." and substitute "REVIEW.

17 PROVIDER MUST BE RESOLVED IN ACCORDANCE WITH ANY APPLICABLE

23 CODES IS USED FOR THE CARE OF A PATIENT WITH A SPECIFIC DIAGNOSIS
