

SENATE COMMITTEE OF REFERENCE AMENDMENT

Committee on Appropriations.

HB22-1409 be amended as follows:

1 Amend reengrossed bill, page 2, lines 1 and 2, strike "(7) introductory
2 portion" and substitute "(6)(b) and (7) introductory portion; and **add**
3 (7)(c)".

4 Page 2, strike line 4 and substitute "**reporting - definitions - compliance**
5 **with federal requirements - legislative declaration - repeal.**
6 (6) (b) Except as otherwise required by this subsection (6)(b), all money
7 not expended or encumbered, and all interest earned on the investment or
8 deposit of money in the fund, must remain in the fund and shall not revert
9 to the general fund or any other fund at the end of any fiscal year. The
10 money in the fund is continuously appropriated to the division for the
11 purposes of this section. Any money in the fund not expended or
12 encumbered by December 31, 2022, ~~must revert~~ REVERTS to the general
13 fund; EXCEPT THAT ALL MONEY IN THE FUND NOT EXPENDED OR
14 ENCUMBERED BY DECEMBER 31, 2022, THAT WAS TRANSFERRED TO THE
15 FUND FROM THE ECONOMIC RECOVERY AND RELIEF CASH FUND CREATED
16 IN SECTION 24-75-228 (2)(a), REVERTS TO THE ECONOMIC RECOVERY AND
17 RELIEF CASH FUND.

18 (7) On June 16, 2021, or as soon as".

19 Page 2, line 8, strike "GENERAL FUND" and substitute "ECONOMIC
20 RECOVERY AND RELIEF CASH FUND CREATED IN SECTION 24-75-228
21 (2)(a)".

22 Page 2, after line 9 insert:

23 "(c) (I) THE GENERAL ASSEMBLY FINDS AND DECLARES THAT THE
24 GRANT PROGRAM IS AN IMPORTANT GOVERNMENT SERVICE THAT
25 EXPEDITES ECONOMIC RECOVERY AND REVITALIZES IMPORTANT ECONOMIC
26 INFRASTRUCTURE.

27 (II) THE DIVISION, WITH RESPECT TO EXPENDITURES MADE FROM
28 MONEY TRANSFERRED TO THE FUND FROM THE ECONOMIC RECOVERY AND
29 RELIEF CASH FUND CREATED IN SECTION 24-75-228 (2)(a), AND ANY
30 PERSON THAT RECEIVES A GRANT THAT INCLUDES MONEY TRANSFERRED
31 TO THE FUND FROM THE ECONOMIC RECOVERY AND RELIEF CASH FUND
32 SHALL COMPLY WITH THE COMPLIANCE, REPORTING, RECORD-KEEPING,
33 AND PROGRAM EVALUATION REQUIREMENTS ESTABLISHED BY THE OFFICE
34 OF STATE PLANNING AND BUDGETING AND THE STATE CONTROLLER IN
35 ACCORDANCE WITH SECTION 24-75-226 (5).

36 (III) TO BE ELIGIBLE TO RECEIVE A GRANT THAT INCLUDES MONEY
37 TRANSFERRED TO THE FUND FROM THE ECONOMIC RECOVERY AND RELIEF

1 CASH FUND CREATED IN SECTION 24-75-228 (2)(a), AND THAT WILL BE
2 USED WHOLLY OR PARTLY TO FUND A CAPITAL PROJECT, A GRANT
3 APPLICANT MUST SUBMIT TO THE DIVISION A WRITTEN JUSTIFICATION AS
4 SET FORTH IN 31 CFR 35.6 (b)(4) FOR THE CAPITAL EXPENDITURE; EXCEPT
5 THAT THIS REQUIREMENT DOES NOT APPLY IF THE DIVISION DETERMINES
6 THAT THE WRITTEN JUSTIFICATION IS NOT REQUIRED BASED ON HOW THE
7 EXPENDITURES AUTHORIZED UNDER THIS SECTION WILL BE REPORTED TO
8 THE UNITED STATES DEPARTMENT OF THE TREASURY.".
