

HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on Appropriations.

HB19-1009 be amended as follows:

1 Amend the Public Health Care and Human Services Committee Report,
2 dated March 6, 2019, page 2, lines 11 and 12, strike "AT LEAST FOUR
3 MILLION THREE HUNDRED THOUSAND" and substitute "ONE MILLION".

4 Page 2, line 13, strike "GENERAL FUND" and substitute "MARIJUANA TAX
5 CASH FUND CREATED IN SECTION 39-28.8-501, C.R.S.,"

6 Page 3, strike lines 25 and 26 and substitute:

7 "(a) IS CERTIFIED BY A RECOVERY RESIDENCE CERTIFYING BODY
8 APPROVED BY THE OFFICE OF BEHAVIORAL HEALTH IN THE DEPARTMENT
9 OF HUMAN SERVICES AS SPECIFIED IN SUBSECTION (4) OF THIS SECTION;".

10 Page 3, line 28, strike "OR".

11 Page 3, line 31, strike "SECTION." and substitute "SECTION; OR
12 (d) IS A COMMUNITY-BASED ORGANIZATION THAT PROVIDES
13 REENTRY SERVICES AS DESCRIBED IN SECTION 17-33-101 (7).

14 (4) THE OFFICE OF BEHAVIORAL HEALTH IN THE DEPARTMENT OF
15 HUMAN SERVICES SHALL, BY RULE, DETERMINE THE REQUIREMENTS FOR
16 A RECOVERY RESIDENCE CERTIFYING BODY SEEKING APPROVAL FOR
17 PURPOSES OF SUBSECTION (3)(a) OF THIS SECTION, WHICH RULES MUST
18 INCLUDE A REQUIREMENT THAT A RECOVERY RESIDENCE CERTIFYING BODY
19 INCLUDE A REPRESENTATIVE FROM THE OFFICE ON ITS BOARD.".

20 Rerumber succeeding subsection accordingly.

21 Page 6, after line 27 insert:

22 **"SECTION 4.** In Colorado Revised Statutes, **add** 27-80-119 as
23 follows:

24 **27-80-119. Recovery residence certification grant program -**
25 **created - rules.** (1) THERE IS HEREBY CREATED IN THE OFFICE OF
26 BEHAVIORAL HEALTH IN THE DEPARTMENT THE RECOVERY RESIDENCE
27 CERTIFICATION GRANT PROGRAM TO PROVIDE GRANTS TO RECOVERY
28 RESIDENCES FOR THE PURPOSE OF GAINING CERTIFICATION AS A RECOVERY
29 RESIDENCE AS REQUIRED IN SECTION 25-1.5-108.5.

30 (2) GRANT RECIPIENTS MAY USE THE MONEY RECEIVED THROUGH
31 THE GRANT PROGRAM TO PAY FEES RELATED TO GAINING CERTIFICATION
32 FROM AN APPROVED RECOVERY RESIDENCE CERTIFYING BODY, AS
33 DETERMINED BY THE OFFICE PURSUANT TO SECTION 25-1.5-108.5 (4),

1 INCLUDING THE PAYMENT OF MEMBERSHIP DUES.

2 (3) THE OFFICE SHALL ADMINISTER THE GRANT PROGRAM AND,
3 SUBJECT TO AVAILABLE APPROPRIATIONS, SHALL AWARD GRANTS AS
4 PROVIDED IN THIS SECTION. FOR THE 2020-21 FISCAL YEAR AND EACH
5 FISCAL YEAR THEREAFTER, THE GENERAL ASSEMBLY SHALL APPROPRIATE
6 MONEY FROM THE GENERAL FUND TO THE DEPARTMENT FOR THE PURPOSE
7 OF THE GRANT PROGRAM

8 (4) THE OFFICE SHALL IMPLEMENT THE GRANT PROGRAM IN
9 ACCORDANCE WITH THIS SECTION. PURSUANT TO ARTICLE 4 OF TITLE 24,
10 THE OFFICE SHALL PROMULGATE SUCH RULES AS ARE REQUIRED IN THIS
11 SECTION AND SUCH ADDITIONAL RULES AS MAY BE NECESSARY TO
12 IMPLEMENT THE GRANT PROGRAM. AT A MINIMUM, THE RULES MUST
13 SPECIFY THE TIME FRAMES FOR APPLYING FOR GRANTS, THE FORM OF THE
14 GRANT PROGRAM APPLICATION, AND THE TIME FRAMES FOR DISTRIBUTING
15 GRANT MONEY.

16 **SECTION 5. Appropriation.** (1) For the 2019-20 state fiscal
17 year, \$1,000,000 is appropriated to the department of local affairs. This
18 appropriation is from the marijuana tax cash fund created in section 39-
19 28.8-501 (1), C.R.S. To implement this act, the department may use this
20 appropriation as follows:

21 (a) \$51,675 for use by the division of housing for personal
22 services, which amount is based on an assumption that the division will
23 require an additional 0.9 FTE;

24 (b) \$6,949 for use by the division of housing for operating
25 expenses;

26 (c) \$938,756 for use by the division of housing for low income
27 rental subsidies; and

28 (d) \$2,620 for the purchase of information technology services.

29 (2) For the 2019-20 state fiscal year, \$2,620 is appropriated to the
30 office of the governor for use by the office of information technology.
31 This appropriation is from reappropriated funds received from the
32 department of local affairs under subsection (1)(d) of this section. To
33 implement this act, the office may use this appropriation to provide
34 information technology services for the department of local affairs.

35 (3) For the 2019-20 state fiscal year, \$50,000 is appropriated to
36 the department of human services for use by the office of behavioral
37 health. This appropriation is from the general fund. To implement this act,
38 the office may use this appropriation for the recovery residence
39 certification grant program.".
