

## HOUSE FLOOR AMENDMENT

Second Reading

1 Amend the Finance Committee Report, dated April 8, 2019, page 3, line  
2 31, strike "(1)(h) and (1)(i)" and substitute "(1)(h), (1)(i), and (5)".

3 Page 4, after line 1, insert:

4        "(5) A PERSON MAY NOT OPERATE A LICENSE ISSUED PURSUANT TO  
5 THIS ARTICLE 12 AT THE SAME LOCATION AS A LICENSE OR PERMIT ISSUED  
6 PURSUANT TO ARTICLE 3, 4, OR 5 OF THIS TITLE 44".

7 Page 4, line 36, strike "(14)," and substitute "(14) THAT DOES NOT HOLD  
8 A LICENSE OR PERMIT ISSUED PURSUANT TO ARTICLE 3, 4, OR 5 OF THIS  
9 TITLE 44".

10 Page 7, after line 17, insert:

11        "(d) ALLOW THE CONSUMPTION OF ALCOHOL ON THE LICENSED  
12 PREMISES;".

13 Reletter succeeding paragraphs accordingly.

14 Page 8, line 40, after "(14)" insert "(14) THAT DOES NOT HOLD A LICENSE  
15 OR PERMIT ISSUED PURSUANT TO ARTICLE 3, 4, OR 5 OF THIS TITLE 44".

16 Page 11 after line 4, insert:

17        "(d) SELL ANY RETAIL MARIJUANA OR RETAIL MARIJUANA  
18 PRODUCTS THAT CONTAIN NICOTINE OR, IF THE SALE OF ALCOHOL WOULD  
19 REQUIRE A LICENSE OR PERMIT PURSUANT TO ARTICLE 3, 4, OR 5 OF THIS  
20 TITLE 44, ALCOHOL;

21        "(e) ALLOW THE CONSUMPTION OF ALCOHOL ON THE LICENSED  
22 PREMISES;".

23 Reletter succeeding paragraphs accordingly.

24 Page 12, strike line 37, and substitute "(1), (3)(c), (3)(d), and (4)(g); and  
25 **add** (3)(e) as follows:".

26 Page 13, after line 5, insert:

27        "(3) It is unlawful for a person licensed pursuant to this article 12:  
28            (c) To fail to report a transfer required by section 44-12-309 (10);

29 **or**

30            (d) To fail to report the name of or a change in managers as  
31 required by section 44-12-309 (11); OR

32            (e) To ALLOW THE CONSUMPTION OF ALCOHOLIC BEVERAGES ON  
33 THE LICENSED PREMISES.".
