

SENATE COMMITTEE OF REFERENCE AMENDMENT

Committee on Appropriations.

SB19-199 be amended as follows:

1 Amend the Education Committee Report, dated April 11, 2019, page 11,
2 line 25, strike "AND".

3 Page 11, strike line 26 and substitute:

4 (B) UP TO SEVEN HUNDRED FIFTY THOUSAND DOLLARS TO
5 CONTRACT WITH, AND PAY THE DIRECT ADMINISTRATIVE COSTS INCURRED
6 IN CONTRACTING WITH AND OVERSEEING, A".

7 Page 11, strike line 29 and substitute "(8); AND

8 (C) UP TO TWO MILLION SEVEN HUNDRED FIFTY THOUSAND
9 DOLLARS TO PROVIDE EVIDENCE-BASED TRAINING IN TEACHING READING
10 FOR TEACHERS EMPLOYED BY LOCAL EDUCATION PROVIDERS TO TEACH
11 KINDERGARTEN AND GRADES ONE THROUGH THREE. IF THE ACTUAL
12 DEMAND FOR TRAINING EXCEEDS THE ANTICIPATED DEMAND AND THE
13 AMOUNT ALLOCATED PURSUANT TO THIS SUBSECTION (4)(C)(I)(C) IS
14 INSUFFICIENT TO PAY THE COSTS INCURRED IN PROVIDING THIS TRAINING,
15 THE DEPARTMENT MAY SUBMIT TO THE GENERAL ASSEMBLY DURING THE
16 2019-20 BUDGET YEAR A REQUEST FOR A SUPPLEMENTAL APPROPRIATION
17 IN THE AMOUNT REQUIRED TO FULLY FUND THE COSTS.".

18 Page 11, line 35, strike "USE TEN PERCENT" and substitute "ALLOCATE
19 TWO MILLION FIVE HUNDRED THOUSAND DOLLARS".

20 Page 11, line 38, strike "NINETY PERCENT" and substitute "THE REMAINING
21 AMOUNT".

22 Page 12, strike lines 1 through 24 and substitute:

23 (d) (I) BEGINNING IN THE 2020-21 BUDGET YEAR AND FOR
24 BUDGET YEARS THEREAFTER, THE DEPARTMENT SHALL ANNUALLY EXPEND
25 THE MONEY CREDITED TO THE EARLY LITERACY FUND FOR THE FOLLOWING
26 PURPOSES:

27 (A) TO IMPLEMENT THE PUBLIC INFORMATION CAMPAIGN TO
28 PROMOTE READING DESCRIBED IN SECTION 22-7-1209 (7);

29 (B) TO CONTRACT WITH AND PAY THE DIRECT COSTS INCURRED IN
30 OVERSEEING AN INDEPENDENT EVALUATOR AS PROVIDED IN SECTION
31 22-7-1209 (8);

32 (C) TO IMPLEMENT THE EARLY LITERACY GRANT PROGRAM
33 CREATED IN SECTION 22-7-1211;

34 (D) TO ALLOCATE PER-PUPIL INTERVENTION MONEY TO LOCAL
35 EDUCATION PROVIDERS AS PROVIDED IN SECTION 22-7-1210.5; AND

36 (E) TO PAY THE COSTS INCURRED IN PROVIDING TO LOCAL

1 EDUCATION PROVIDERS TECHNICAL ASSISTANCE IN IMPLEMENTING THIS
2 PART 12 AND TRAINING IN TEACHING READING FOR TEACHERS EMPLOYED
3 TO TEACH KINDERGARTEN AND GRADES ONE THROUGH THREE;
4 MONITORING THE USE OF MONEY RECEIVED AS PER-PUPIL INTERVENTION
5 MONEY OR GRANTS THROUGH THE EARLY LITERACY GRANT PROGRAM; AND
6 FULFILLING THE ADMINISTRATIVE REQUIREMENTS SPECIFIED IN THIS PART
7 12.

8 (II) THE GENERAL ASSEMBLY SHALL ANNUALLY APPROPRIATE IN
9 THE GENERAL APPROPRIATIONS BILL THE AMOUNT THAT THE DEPARTMENT
10 MAY EXPEND FOR THE PURPOSES SPECIFIED IN SUBSECTION (4)(d)(I) OF
11 THIS SECTION.".
