

## HOUSE FLOOR AMENDMENT

Second Reading

- 1 Amend reengrossed bill, page 9, strike lines 22 and 23 and substitute  
2 "MISSION OF THE PUBLIC SCHOOL FUND."
- 3 Page 12, line 13, strike "FUND." and substitute "COMMUNITY INVESTMENT  
4 PORTFOLIO."
- 5 Page 12, strike lines 23 and 24 and substitute "ASSISTANCE THAT HAS  
6 BEEN PROVIDED THROUGH THE SHARED EQUITY DOWN PAYMENT  
7 ASSISTANCE PROGRAM, BY THE FOLLOWING DATES:"
- 8 Page 13, line 8, strike "FULLY"
- 9 Page 13, line 27, strike "DOWN PAYMENT EQUITY" and substitute "EQUITY  
10 DOWN PAYMENT"
- 11 Page 14, strike lines 12 through 14 and substitute "PROPORTIONAL SHARE  
12 OF APPRECIATION IN A PROPERTY NEVER EXCEEDING THE PERCENTAGE OF  
13 THE TOTAL PURCHASE PRICE THAT THE SHARED EQUITY DOWN PAYMENT  
14 ASSISTANCE PROGRAM'S FINANCIAL ASSISTANCE REPRESENTED, AS  
15 FURTHER DESCRIBED IN PROGRAM GUIDELINES; AND"
- 16 Page 14, line 24, strike "THE" and substitute "UNLESS INVESTMENTS IN  
17 THE SHARED EQUITY DOWN PAYMENT ASSISTANCE PROGRAM HAVE BEEN  
18 DISCONTINUED AND THERE IS NO FUND MONEY INVESTED IN THE SHARED  
19 EQUITY DOWN PAYMENT ASSISTANCE PROGRAM, THE"
- 20 Page 15, line 9, after "OF" insert "PRINCIPAL REPAID AND"
- 21 Page 15, strike line 11 and substitute:
- 22 "(VII) THE AMOUNT OF LOSS, IF ANY,"
- 23 Page 15, after line 13 insert:  
24 "(f) THE PROGRAM MANAGER SHALL PRESENT THE FIRST ANNUAL  
25 REPORT REQUIRED BY SUBSECTION (4)(e) OF THIS SECTION NO LATER THAN  
26 DECEMBER 1, 2027. EACH ANNUAL REPORT MUST BE PUBLISHED ON THE  
27 PROGRAM MANAGER'S WEBSITE AND DISTRIBUTED TO: THE HOUSE OF  
28 REPRESENTATIVES EDUCATION COMMITTEE AND THE SENATE EDUCATION  
29 COMMITTEE, OR THEIR SUCCESSOR COMMITTEES; THE PUBLIC SCHOOL  
30 FUND INVESTMENT BOARD; AND THE COLORADO DEPARTMENT OF  
31 EDUCATION."

- 1 Reletter succeeding paragraph accordingly.
- 2 After "SCHOOL" insert "FUND" on: **Page 13**, lines 9, 13, and 15.
- 3 Before "PROGRAM" insert "SHARED EQUITY DOWN PAYMENT ASSISTANCE"
- 4 on: **Page 14**, lines 26 and 27; and **Page 15**, lines 1, 2, and 5.
