

HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on Business Affairs & Labor.

HB21-1159 be amended as follows:

1 Amend printed bill, page 2, lines 9 through 11, strike "RETAIL  
2 MARIJUANA, RETAIL MARIJUANA PRODUCTS, OR BRANDED MERCHANDISE  
3 THAT IS AVAILABLE FOR SALE FROM THE RETAIL MARIJUANA STORE" and  
4 substitute "PRODUCTS AVAILABLE AND REGULATED FOR SALE IN THE  
5 RETAIL MARIJUANA STORE ASSOCIATED WITH THE DELIVERY PERMIT".

6 Page 2, lines 21 and 22, strike "price; EXCEPT THAT AN ONLINE PLATFORM  
7 MUST NOT HOLD PRE-PAID ACCOUNTS FOR A LICENSED RETAIL MARIJUANA  
8 STORE." and substitute "price. ONLY A LICENSED MEDICAL MARIJUANA  
9 STORE OR RETAIL MARIJUANA STORE MAY HOLD PREPAID CUSTOMER  
10 FUNDS. THIS PROVISION DOES NOT PROHIBIT A THIRD-PARTY FINANCIAL  
11 INSTITUTION, CREDIT CARD COMPANY, OR OTHER PAYMENT PROCESSOR  
12 FROM FACILITATING A PAYMENT BY A CUSTOMER TO A MEDICAL  
13 MARIJUANA STORE OR A RETAIL MARIJUANA STORE FOR PRODUCTS  
14 PREVIOUSLY ORDERED FROM THE MEDICAL MARIJUANA STORE OR RETAIL  
15 MARIJUANA STORE BY THE CUSTOMER.".

16 Page 2, strike line 23.

17 Page 3, strike lines 1 through 12.

18 Rerumber succeeding sections accordingly.

19 Page 4, after line 4 insert:

20 "SECTION 4. In Colorado Revised Statutes, 44-10-803, **add** (4)  
21 as follows:

22 **44-10-803. Fees.** (4) THE STATE LICENSING AUTHORITY SHALL  
23 WAIVE THE INITIAL APPLICATION AND LICENSE FEES FOR TRANSPORTER  
24 LICENSES AND DELIVERY PERMITS IF THE PERSON APPLYING FOR THE  
25 TRANSPORTER LICENSE OR DELIVERY PERMIT MEETS THE CRITERIA  
26 ESTABLISHED PURSUANT TO SECTION 44-10-308 (4).

27 **SECTION 5.** In Colorado Revised Statutes, 44-10-1401, **amend**  
28 (2) as follows:

29 **44-10-1401. Sunset review - repeal of article.** (2) Prior to the  
30 repeal of this article 10, the department of regulatory agencies shall  
31 conduct a sunset review as described in section 24-34-104 (5), AND, IN  
32 THAT REVIEW, THE DEPARTMENT OF REGULATORY AGENCIES MUST REVIEW  
33 THE METRICS AND IMPACTS OF THE REGULATIONS ON RETAIL SALES.".

34 Rerumber succeeding section accordingly.
