2       **"SECTION 14.** In Colorado Revised Statutes, 39-21-112, **add**  
3 (10) as follows:

4       **39-21-112. Duties and powers of executive director.**  
5 (10) (a) NOTWITHSTANDING ANY OTHER PROVISION OF LAW, AND  
6 PURSUANT TO 26 U.S.C. 6402 AND 31 U.S.C. 3716 (b) AND (h)(1), OR ANY  
7 SUCCESSOR SECTIONS, THE EXECUTIVE DIRECTOR MAY ENTER INTO A  
8 RECIPROCAL AGREEMENT WITH THE UNITED STATES GOVERNMENT TO  
9 OFFSET:

10       (I) THE CLAIM OF ANY PERSON AGAINST THE STATE, INCLUDING  
11 ANY STATE TAX OVERPAYMENT TO WHICH THE PERSON MAY BE ENTITLED,  
12 TO ANY DEBT OF THE PERSON OWED TO THE UNITED STATES GOVERNMENT  
13 THAT THE UNITED STATES GOVERNMENT HAS CERTIFIED AS FINAL, DUE,  
14 AND OWING, WITH ALL APPEALS AND LEGAL ACTIONS HAVING BEEN  
15 WAIVED OR EXHAUSTED; AND

16       (II) ANY CLAIM OF ANY PERSON AGAINST THE UNITED STATES  
17 GOVERNMENT TO ANY LIQUIDATED DEBT OF THE PERSON OWED TO THE  
18 STATE. ANY FEES ASSOCIATED WITH ANY OFFSET OF FEDERAL MONEY WILL  
19 BE DEDUCTED BY THE UNITED STATES GOVERNMENT FROM THE AMOUNT  
20 OF MONEY OFFSET, WHICH MAY THEN BE ADDED TO THE BALANCE OF THE  
21 DEBT OWED, BUT ANY FEES ASSOCIATED WITH ANY OFFSET OF STATE  
22 MONEY WILL NOT BE CHARGED TO THE UNITED STATES GOVERNMENT.

23       (b) NOTWITHSTANDING ANY OTHER PROVISION OF LAW, THE  
24 EXECUTIVE DIRECTOR MAY ENTER INTO A RECIPROCAL AGREEMENT WITH  
25 ANY STATE TO OFFSET:

26       (I) THE CLAIM OF ANY PERSON AGAINST THE STATE TO ANY DEBT  
27 OF THE PERSON OWED TO ANY STATE THAT HAS CERTIFIED THE DEBT AS  
28 FINAL, DUE, AND OWING, WITH ALL APPEALS AND LEGAL ACTIONS HAVING  
29 BEEN WAIVED OR EXHAUSTED; AND

30       (II) ANY CLAIM OF ANY PERSON AGAINST ANY STATE TO ANY  
31 LIQUIDATED DEBT OF THE PERSON OWED TO THE STATE.".
