

- 1 Amend printed bill, page 2, line 3, strike "portion and (1)(a)" and
- 2 substitute "portion, (1)(a), and (1)(b)".
- 3 Page 2, line 7, strike "five" and substitute "five SEVEN".
- 4 Page 2, line 12, strike "three of the five" and substitute "three of the five
- 5 FOUR OF THE SEVEN".
- 6 Page 2, line 14, strike "THE" and substitute "A".
- 7 Page 2, line 15, after "IS" insert "SERVING PURSUANT TO SUBSECTION
- 8 (1)(a) OF THIS SECTION AS".
- 9 Page 3, strike lines 3 through 6 and substitute: "years; ~~and~~; one member
- 10 shall be a registered elector of ANY COUNTY IN the state OTHER THAN
- 11 GILPIN COUNTY OR TELLER COUNTY who is not employed in ~~any~~ A
- 12 profession or industry otherwise described in this subsection (1)(a); ONE
- 13 MEMBER SHALL BE A REGISTERED ELECTOR OF GILPIN COUNTY; AND ONE
- 14 MEMBER SHALL BE A REGISTERED ELECTOR OF TELLER COUNTY. THE
- 15 REGISTERED ELECTOR MEMBERS OF THE COMMISSION FROM GILPIN AND
- 16 TELLER COUNTIES MAY BE EMPLOYED IN A PROFESSION OR INDUSTRY
- 17 OTHERWISE DESCRIBED IN THIS SUBSECTION (1)(a)".
- 18 Page 3, after line 8 insert:
 - 19 "(b) Initial members shall be appointed to the commission by the
 - 20 governor as follows: One member to serve until July 1, 1992, one member
 - 21 to serve until July 1, 1993, one member to serve until July 1, 1994, and
 - 22 two members to serve until July 1, 1995. ONE OF THE INITIAL MEMBERS
 - 23 WHO IS A REGISTERED ELECTOR OF GILPIN OR TELLER COUNTY SHALL BE
 - 24 APPOINTED TO SERVE UNTIL JULY 1, 2023, AND THE OTHER SHALL BE
 - 25 APPOINTED TO SERVE UNTIL JULY 1, 2025. All subsequent appointments
 - 26 shall be for terms of four years. No member of the commission shall be
 - 27 eligible to serve more than two consecutive terms.".
- 28 Page 4, strike line 5 and substitute:
 - 29 "(I) A MEMBER OF THE COMMISSION SERVING PURSUANT TO
 - 30 SUBSECTION (1)(a) OF THIS SECTION AS A REGISTERED".
