- 6 TWO PROGRAM YEARS IN WHICH AN EDUCATION PROVIDER OPERATES A
- 7 PROGRAM:".
- 8 Page 6, line 7, strike "APPLICABLE".
- 9 Page 6, line 8, strike "APPLICABLE".

- 16 Page 7, line 6, before "SCHOOLS" insert "ELEMENTARY".
- 17 Page 7, line 9, after "A" insert "TWO-YEAR".
- 18 Page 7, line 12, after "SCHOOL" insert "THAT SERVES KINDERGARTEN AND
- 19 GRADES ONE AND TWO AND".
- 20 Page 7, line 15, after "A" insert "TWO-YEAR".
- 21 Page 7, line 18, after "MONEY" insert "FOR UP TO TWO CONSECUTIVE
- 22 SCHOOL YEARS".
- 23 Page 8, line 9, strike "PROGRAM;" and substitute "PROGRAM FOR EACH OF
- 24 THE PROGRAM YEARS;".

- 1 Page 8, line 22, after "SERVICES" insert "FOR ONE OR BOTH OF THE  
2 PROGRAM YEARS".
- 3 Page 8, lines 26 and 27, strike "THE APPLICABLE SCHOOL YEAR." and  
4 substitute "EACH OF THE PROGRAM YEARS IN WHICH THE ELIGIBLE  
5 STUDENT PARTICIPATES".
- 6 Page 9, lines 3 and 4, strike "THE APPLICABLE SCHOOL YEAR." and  
7 substitute "PROGRAM YEARS".
- 8 Page 9, line 8, strike "THE APPLICABLE SCHOOL YEAR" and substitute  
9 "EACH OF THE PROGRAM YEARS".
- 10 Page 9, line 14, strike "APPLICABLE SCHOOL YEAR" and substitute  
11 "PROGRAM YEARS".
- 12 Page 9, line 18, after "(1)" insert "(a)".
- 13 Page 9, line 21, strike "(a) (I)" and substitute "(I) (A)" and after  
14 "ENROLLED" insert "IN KINDERGARTEN OR FIRST GRADE".
- 15 Page 9, line 22, strike "APPLICABLE SCHOOL" and substitute "INITIAL  
16 PROGRAM".
- 17 Page 9, strike lines 24 and 25 and substitute:
- 18 "(B) FOR THE SCHOOL YEAR THAT IMMEDIATELY PRECEDES THE  
19 INITIAL PROGRAM YEAR, THE STUDENT WAS TOO YOUNG TO ENROLL IN  
20 KINDERGARTEN OR WAS ELIGIBLE TO ENROLL IN KINDERGARTEN OR FIRST  
21 GRADE BUT WAS NOT ENROLLED IN A PUBLIC".
- 22 Page 9, line 27, strike "APPLICABLE SCHOOL" and substitute "INITIAL  
23 PROGRAM".
- 24 Page 10, line 3, strike "(b) (I)" and substitute "(II) (A)".
- 25 Page 10, lines 4 and 5, strike "APPLICABLE SCHOOL" and substitute  
26 "INITIAL PROGRAM".
- 27 Page 10, line 8, strike "(II)" and substitute "(B)".
- 28 Page 10, lines 9 and 10, strike "APPLICABLE SCHOOL" and substitute  
29 "INITIAL PROGRAM".

1 Page 10, after line 13 insert:

2 "(b) IN THE SECOND PROGRAM YEAR, AN ELIGIBLE STUDENT  
3 REMAINS ELIGIBLE SO LONG AS THE ELIGIBLE STUDENT DOES NOT ENROLL  
4 IN A SCHOOL DISTRICT OR INSTITUTE CHARTER SCHOOL OTHER THAN THE  
5 ONE THAT OPERATES THE PROGRAM.

6 (c) NOTWITHSTANDING ANY PROVISIONS OF THIS SUBSECTION (1)  
7 TO THE CONTRARY, AN ELIGIBLE STUDENT SHALL NOT PARTICIPATE IN  
8 MORE THAN ONE TWO-YEAR PROGRAM."

9 Page 10, strike lines 16 and 17 and substitute "SUBMITTING AN  
10 APPLICATION TO THE EDUCATION PROVIDER THAT OPERATES A PROGRAM  
11 IN WHICH THE STUDENT IS ELIGIBLE TO PARTICIPATE FOR EACH OF THE  
12 PROGRAM YEARS. THE".

13 Page 10, line 21, strike "APPLICABLE" and substitute "INITIAL OR SECOND  
14 PROGRAM".

15 Page 11, strike line 1 and substitute "DURING THE IMMEDIATELY  
16 PRECEDING".

17 Page 11, line 6, strike "APPLICABLE SCHOOL" and substitute "PROGRAM".

18 Page 11, lines 16 and 17, strike "THE APPLICABLE SCHOOL YEAR." and  
19 substitute "EACH OF THE PROGRAM YEARS IN WHICH THE ELIGIBLE  
20 STUDENT PARTICIPATES."

21 Page 11, line 19, strike "THE APPLICABLE SCHOOL" and substitute "EACH  
22 PROGRAM".
