

HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on Health & Human Services.

HB24-1223 be amended as follows:

- 1 Amend printed bill, page 3, strike lines 21 through 23 and substitute:
2 **"education. (3)** A COUNTY DEPARTMENT SHALL NOT ADD
3 ADDITIONAL REQUIRED ELIGIBILITY CRITERIA TO THE APPLICATION OR
4 REDETERMINATION PROCESS.
- 5 Page 3, line 25, after "(1.5)" insert "and (3.5)".
- 6 Page 4, after line 9, insert:
7 **"(3.5) "CUSTOMER SERVICE"** MEANS ACTIVITIES THAT PROVIDE
8 ONE-ON-ONE SUPPORT FOR FAMILIES IN SUBMITTING APPLICATIONS AND
9 NAVIGATING SERVICES, AND PROVIDING ACCESS TO TRANSPARENT AND
10 EASY-TO-UNDERSTAND CONSUMER EDUCATION RESOURCES FOR THE
11 COLORADO CHILD CARE ASSISTANCE PROGRAM AND OTHER COUNTY
12 HUMAN SERVICES-ADMINISTERED PUBLIC BENEFIT PROGRAMS."
- 13 Page 4, line 15, strike "The" and substitute "WITHOUT CREATING A NEW
14 INFORMATION TECHNOLOGY SYSTEM, the".
- 15 Page 4, line 20, strike "THE APPLICATION MUST SPECIFY INCOME" and
16 substitute "THE DEPARTMENT AND A COUNTY DEPARTMENT SHALL
17 PUBLICLY DISCLOSE OR PUBLICIZE INCOME".
- 18 Page 5, line 11, strike "RESIDENCY; THE AGE AND IDENTITY" and substitute
19 "RESIDENCY AND NAME OF THE APPLICANT; THE AGE AND NAME".
- 20 Page 5, lines 13 and 14, strike "SCHEDULE, IF NONTRADITIONAL-CARE
21 HOURS ARE REQUESTED AT THE TIME OF APPLICATION OR
22 REDETERMINATION;"
- 23 Page 5, line 18, strike "IMMUNIZATION HISTORY OR CHILD CARE PROVIDER
24 PREFERENCES," and substitute "IMMUNIZATION HISTORY,".

26 Page 5, line 19, strike "A" and substitute "CHILD CARE THAT IS PROVIDED
27 OUTSIDE OF THE CHILD'S HOME BY A NON-RELATIVE".
- 28 Page 5, line 21, after the period add "THE COUNTY DEPARTMENT MAY
29 REQUEST, BUT SHALL NOT REQUIRE, INFORMATION ON CHILD CARE
30 PROVIDER SELECTION AT THE TIME OF APPLICATION."
