PURPOSE: Reduces the appropriation to the Administration division in the Department of **Law** by \$4,876,658 total funds, including \$1,133,277 General Fund; reduces the appropriation to the Administration and Support division in the Department of **Public Health and Environment** by \$6,891,186 total funds, including \$2,779,305 General Fund; and reduces the appropriation to the Executive Director's Office and Administrative Services division in the Department of **Regulatory Agencies** by \$2,275,986 total funds, including \$249,186 General Fund.
