6 **"SECTION 7.** In Colorado Revised Statutes, 23-3.3-103, **amend**
7 **(5); and add (12), (13), and (14) as follows:**

8 **23-3.3-103. Annual appropriations - repeal.** (5) The provisions
9 of subsection (1) of this section concerning appropriations for student
10 financial assistance under this article 3.3 shall not apply to appropriations
11 made to the forest restoration and wildfire risk mitigation grant program
12 cash fund created in section 23-31-301 (8.5)(a) OR THE HEALTHY FORESTS
13 AND VIBRANT COMMUNITIES FUND CREATED IN SECTION 23-31-313 (10).
14 (12) THE PROVISIONS OF SUBSECTION (1) OF THIS SECTION
15 CONCERNING APPROPRIATIONS FOR STUDENT FINANCIAL ASSISTANCE
16 UNDER THIS ARTICLE 3.3 SHALL NOT APPLY TO APPROPRIATIONS MADE FOR
17 THE TIMBER, FOREST HEALTH, AND WILDFIRE MITIGATION INDUSTRIES
18 WORKFORCE DEVELOPMENT PROGRAM PURSUANT TO SECTION 23-31-320.
19 (13) (a) THE PROVISIONS OF SUBSECTION (1) OF THIS SECTION
20 CONCERNING APPROPRIATIONS FOR STUDENT FINANCIAL ASSISTANCE
21 UNDER THIS ARTICLE 3.3 SHALL NOT APPLY TO APPROPRIATIONS MADE FOR
22 THE EXPANSION OF FORESTRY AND WILDFIRE MITIGATION DEGREE AND
23 CERTIFICATE PROGRAMS PURSUANT TO SECTION 23-1-142.
24 (b) THIS SUBSECTION (13) IS REPEALED, EFFECTIVE JULY 1, 2027.
25 (14) THE PROVISIONS OF SUBSECTION (1) OF THIS SECTION
26 CONCERNING APPROPRIATIONS FOR STUDENT FINANCIAL ASSISTANCE
27 UNDER THIS ARTICLE 3.3 SHALL NOT APPLY TO APPROPRIATIONS MADE FOR
28 THE RECRUITMENT OF WILDLAND FIRE PREVENTION AND MITIGATION
29 EDUCATORS PROGRAM PURSUANT TO SECTION 23-81-102.

30 **SECTION 8. Appropriation.** (1) For the 2023-24 state fiscal
31 year, \$15,000 is appropriated to the healthy forests and vibrant
32 communities fund created in section 23-31-313 (10), C.R.S. This
33 appropriation is from the general fund. The department of higher
34 education is responsible for the accounting related to this appropriation.
35 (2) For the 2023-24 state fiscal year, \$1,545,034 is appropriated
36 to the department of higher education. This appropriation is from the
37 general fund. To implement this act, the department may use this
38 appropriation as follows:
39 (a) \$114,384 for the Colorado state forest service at Colorado
40 state university

1 (b) \$1,180,650 for use by the Colorado commission on higher
2 education for new and expanded forestry programs; and
3 (c) \$250,000 for the college opportunity fund program to be used
4 for limited purpose fee-for-service contracts with state institutions.
5 (3) For the 2023-24 state fiscal year, \$250,000 is appropriated to
6 the department of higher education. This appropriation is from
7 reappropriated funds received from the limited purpose fee-for-service
8 contracts with state institutions under subsection (2)(c) of this section. To
9 implement this act, the department may use this appropriation for the
10 state board for community colleges and occupational education state
11 system colleges.
12 **SECTION 9. Safety clause.** The general assembly hereby finds,
13 determines, and declares that this act is necessary for the immediate
14 preservation of the public peace, health, or safety."."
