

HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on Energy & Environment.

HB24-1338 be amended as follows:

- 1 Amend printed bill, page 5, line 5, strike "AND".
- 2 Page 5, strike lines 7 and 8 and substitute "CUMULATIVE IMPACTS AND HOW THOSE PROBLEMS AND INDICATORS CAN BE AVOIDED, MINIMIZED, AND MITIGATED, BUT SHOULD NOT RECOMMEND SOLUTIONS TO INDIVIDUAL AGENCIES; AND
 - 6 (f) SHOULD EMPOWER AGENCIES AND LOCAL GOVERNMENTS TO SCORE, EVALUATE, OR COMPARE ALTERNATIVE MITIGATION OPTIONS PROPOSED FOR FUTURE PROJECTS TO ENSURE THAT THE FUTURE PROJECTS ARE EFFECTIVE WHILE CONSIDERING POTENTIAL UNINTENDED 10 CONSEQUENCES.".
- 11 Page 7, line 10, strike "AND".
- 12 Page 7, line 12, strike "PROCESS." and substitute "PROCESS; AND
 - 13 (d) ENSURE THAT AN EECIA IS CRAFTED TO BE COMPREHENSIBLE, EASY TO UTILIZE, AND ACCESSIBLE. AS USED IN THIS SUBSECTION (5)(d), "ACCESSIBLE" INCLUDES ENSURING THAT THE DATA SUPPORTING AN EECIA IS TRANSPARENT, TRANSLATED FROM ENGLISH INTO THE TWO 17 MOST PREVALENT OTHER LANGUAGES SPOKEN IN THE RELEVANT 18 COMMUNITY, AND MADE READILY AVAILABLE TO COMMUNITIES.".
- 19 Page 7, line 13, strike "THE" and substitute "(a) EXCEPT AS PROVIDED IN 20 SUBSECTION (6)(b) OF THIS SECTION, THE".
- 21 Page 7, after line 16 insert:
 - 22 "(b) THE DEPARTMENT SHALL NOT ACCEPT GIFTS, GRANTS, OR DONATIONS FROM INDUSTRY INTERESTS. AS USED IN THIS SUBSECTION 24 (6)(b), "INDUSTRY INTEREST" MEANS AN ENTITY THAT CURRENTLY HOLDS 25 OR THAT APPLIED TO RECEIVE A PERMIT OR LICENSE FROM THE DIVISION OF 26 ADMINISTRATION OR THE HAZARDOUS MATERIALS AND WASTE 27 MANAGEMENT DIVISION.".
