12 FACILITY DEVELOPMENT TOOLKIT AND TECHNICAL ASSISTANCE PROGRAM;

13 (B) ON OR AFTER JULY 1, 2025, BUT BEFORE JULY 1, 2028, THE  
14 DIVISION SHALL USE MONEY IN THE FUND PURSUANT TO THE TRANSFER  
15 MADE PURSUANT TO SUBSECTION (3) OF THIS SECTION TO MAKE GRANTS  
16 PURSUANT TO THE GRANT PROGRAMS AND TO IMPLEMENT AND  
17 ADMINISTER THE GRANT PROGRAMS AND THE CHILD CARE FACILITY  
18 DEVELOPMENT TOOLKIT AND TECHNICAL ASSISTANCE PROGRAM; AND

19 (C) ON OR AFTER JULY 1, 2028, BUT BEFORE JULY 1, 2029, THE  
20 DIVISION SHALL USE MONEY IN THE FUND PURSUANT TO THE TRANSFER  
21 MADE PURSUANT TO SUBSECTION (3) OF THIS SECTION TO MAKE GRANTS  
22 PURSUANT TO THE CHILD CARE FACILITY DEVELOPMENT CAPITAL GRANT  
23 PROGRAM.".

26 "(4) THE DIVISION MAY SEEK, ACCEPT, AND EXPEND GIFTS,
