HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on Transportation, Housing & Local Government.

HB24-1237 be amended as follows:

1 Amend printed bill, page 3, line 6, after "a" insert "licensed".

2 Page 5, after line 13 insert:

3 "(5) "FUND" MEANS THE CHILD CARE FACILITY DEVELOPMENT
4 CASH FUND CREATED IN SECTION 24-32-3705 (1)(a).

5 (6) "INSTITUTION OF HIGHER EDUCATION" MEANS A PRIVATE
6 INSTITUTION OF HIGHER EDUCATION, AS DEFINED IN SECTION 23-18-102
7 (9), OR A STATE INSTITUTION OF HIGHER EDUCATION, AS DEFINED IN
8 SECTION 23-18-102 (10), THAT OFFERS CHILD CARE OR THE AURARIA
9 HIGHER EDUCATION CENTER."

10 Renumber succeeding subsections accordingly.

11 Page 5, line 17, strike "OR A TRIBAL GOVERNMENT." and substitute "A
12 TRIBAL GOVERNMENT, OR AN EARLY CHILDHOOD DEVELOPMENT SERVICE
13 DISTRICT CREATED PURSUANT TO ARTICLE 21 OF TITLE 32.

14 (9) "PUBLIC SCHOOL" MEANS A SCHOOL, INCLUDING A DISTRICT
15 CHARTER SCHOOL, OF A SCHOOL DISTRICT; A SCHOOL OPERATED BY A
16 BOARD OF COOPERATIVE SERVICES; OR AN INSTITUTE CHARTER SCHOOL."

17 Page 5, after line 21 insert:

18 "(a) "ELIGIBLE RECIPIENT" MEANS A CHILD CARE PROVIDER,
19 DEVELOPER, EMPLOYER, LOCAL GOVERNMENT, PUBLIC SCHOOL, OR
20 INSTITUTION OF HIGHER EDUCATION."

21 Reletter succeeding paragraphs accordingly.

22 Page 6, strike lines 4 and 5 and substitute "AND RELATED PROFESSIONALS
23 TO ENABLE ELIGIBLE RECIPIENTS TO".

24 Page 11, line 4, strike "INTEREST IN" and substitute "COMMITMENT TO".

25 Page 11, line 7, strike "AN INTEREST IN" and substitute "A COMMITMENT
26 TO".

27 Page 12, line 5, strike "GOVERNMENT" and substitute "GOVERNMENT, A
28 PUBLIC SCHOOL, AN INSTITUTE OF HIGHER EDUCATION, OR".

29 Page 12, lines 21 and 22, strike "LOCAL GOVERNMENT'S" and substitute

1 "ELIGIBLE ENTITY'S".

2 Page 16, after line 10 insert:

3 **"24-32-3705. Child care facility development cash fund -**
4 **definition - repeal.** (1) (a) THE CHILD CARE FACILITY DEVELOPMENT
5 CASH FUND IS CREATED IN THE STATE TREASURY. THE FUND CONSISTS OF
6 MONEY CREDITED TO THE FUND PURSUANT TO SUBSECTION (3) OF THIS
7 SECTION AND ANY OTHER MONEY THAT THE GENERAL ASSEMBLY MAY
8 APPROPRIATE OR TRANSFER TO THE FUND.

9 (b) THE STATE TREASURER SHALL CREDIT ALL INTEREST AND
10 INCOME DERIVED FROM THE DEPOSIT AND INVESTMENT OF MONEY IN THE
11 FUND TO THE FUND.

12 (c) MONEY IN THE FUND IS CONTINUOUSLY APPROPRIATED TO THE
13 DIVISION FOR THE PURPOSES SET FORTH IN SUBSECTION (2) OF THIS
14 SECTION.

15 (2) (a) SUBJECT TO THE PROVISIONS SET FORTH IN SUBSECTION
16 (2)(b) OF THIS SECTION, THE DIVISION SHALL USE MONEY IN THE FUND TO
17 MAKE GRANTS PURSUANT TO THE CHILD CARE FACILITY DEVELOPMENT
18 PLANNING GRANT PROGRAM CREATED IN SECTION 24-32-3703 (2)(a) AND
19 THE CHILD CARE FACILITY DEVELOPMENT CAPITAL GRANT PROGRAM
20 CREATED IN SECTION 24-32-3704 (2) AND TO IMPLEMENT AND ADMINISTER
21 BOTH OF THE GRANT PROGRAMS AND THE CHILD CARE FACILITY
22 DEVELOPMENT TOOLKIT AND TECHNICAL ASSISTANCE PROGRAM CREATED
23 IN SECTION 24-3-3702 (2).

24 (b) (I) THE DIVISION MAY EXPEND UP TO SEVEN PERCENT OF THE
25 MONEY APPROPRIATED OR TRANSFERRED TO THE FUND TO PAY FOR THE
26 DIRECT AND INDIRECT COSTS IN ADMINISTERING THE PROGRAMS. ALL
27 ADMINISTRATIVE COSTS MUST BE PAID OUT OF THE MONEY TRANSFERRED
28 TO THE FUND PURSUANT TO SUBSECTION (3) OF THIS SECTION.

29 (II) THE DIVISION SHALL EXPEND MONEY APPROPRIATED OR
30 TRANSFERRED TO THE FUND THAT IT DOES NOT EXPEND FOR DIRECT AND
31 INDIRECT COSTS IN ADMINISTERING THE PROGRAMS BASED ON NEED OR
32 DEMAND FOR EACH PROGRAM.

33 (c) AS USED IN THIS SUBSECTION (2), "PROGRAMS" MEANS THE
34 CHILD CARE FACILITY DEVELOPMENT PLANNING GRANT PROGRAM
35 CREATED IN SECTION 24-32-3703 (2)(a), THE CHILD CARE FACILITY
36 DEVELOPMENT CAPITAL GRANT PROGRAM CREATED IN SECTION
37 24-32-3704 (2), AND THE CHILD CARE FACILITY DEVELOPMENT TOOLKIT
38 AND TECHNICAL ASSISTANCE PROGRAM CREATED IN SECTION 24-3-3702
39 (2).

40 (3) ON AUGUST 15, 2024, THE STATE TREASURER SHALL TRANSFER
41 THREE MILLION THREE HUNDRED THOUSAND DOLLARS FROM THE GENERAL

1 FUND TO THE FUND.

2 (4) THE STATE TREASURER SHALL TRANSFER ALL UNEXPENDED
3 AND UNENCUMBERED MONEY IN THE FUND ON JULY 1, 2028, TO THE
4 GENERAL FUND.

5 (5) THIS SECTION IS REPEALED, EFFECTIVE JULY 1, 2028.".
