

HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on Agriculture, Livestock, & Water.

HB22-1148 be amended as follows:

1 Amend printed bill, page 2, strike lines 2 through 5 and substitute:

2 "SECTION 1. In Colorado Revised Statutes, 24-33.5-1228, add  
3 (2.7) as follows:

4 **24-33.5-1228. Colorado firefighting air corps - creation -**  
5 **powers - aircraft acquisitions required - center of excellence -**  
6 **unmanned aircraft systems study and pilot program - Colorado**  
7 **firefighting air corps fund - creation - report - remote wildfire**  
8 **camera technology pilot project - rules - repeal.** (2.7) (a) IN ADDITION  
9 TO PERFORMING THE FUNCTIONS DESCRIBED IN SUBSECTION (2.5)(b) OF  
10 THIS SECTION, ON OR BEFORE APRIL 1, 2023, THE CENTER OF EXCELLENCE  
11 SHALL".

12 Page 2, strike line 8 and substitute "WILDFIRES."

13 Page 2, line 9, strike "(2)" and substitute "(b)".

14 Page 2, line 10, strike "BOARD" and substitute "CENTER OF EXCELLENCE".

15 Page 2, line 18, strike "(3) THE BOARD" and substitute "(c) THE CENTER  
16 OF EXCELLENCE".

17 Page 2, line 23, strike "BOARD" and substitute "CENTER OF EXCELLENCE".

18 Page 3, line 1, strike "(4)" and substitute "(d)".

19 Page 3, line 2, strike "BOARD" and substitute "CENTER OF EXCELLENCE".

20 Page 3, line 10, strike "(4)" and substitute "(2.7)(d)".

21 Page 3, line 12, strike "(5) THE BOARD" and substitute "(e) THE CENTER  
22 OF EXCELLENCE".

23 Page 3, after line 14 insert:

24 "(f) ON JULY 1, 2022, THE STATE TREASURER SHALL TRANSFER  
25 TWO MILLION DOLLARS FROM THE GENERAL FUND TO THE COLORADO  
26 FIREFIGHTING AIR CORPS FUND CREATED IN SUBSECTION (3)(a) OF THIS  
27 SECTION. THE DIVISION SHALL USE THE MONEY TRANSFERRED PURSUANT  
28 TO THIS SUBSECTION (2.7)(f) FOR THE PURPOSES SPECIFIED IN SUBSECTION  
29 (2.7) (a) AND (b) OF THIS SECTION."

- 1 Page 3, strike lines 23 through 27.
- 2 Renumber succeeding section accordingly.
