Committee on Health & Human Services.

SB25-042 be amended as follows:

- 1 Amend reengrossed bill, page 3, line 4, strike "**stakeholder group** -".
- 2 Page 3, lines 17 and 18, strike "CONVENE A STAKEHOLDER GROUP" and
3 substitute "CONSULT WITH STAKEHOLDERS".
- 4 Page 3, line 21, strike "DECEMBER 31, 2025," and substitute "JUNE 30,
5 2026,".
- 6 Page 3, lines 23 and 24, strike "CONVENE A STAKEHOLDER GROUP" and
7 substitute "CONSULT WITH STAKEHOLDERS".
- 8 Page 4, strike line 7 and substitute "INCLUDING FUNDING FOR TREATMENT
9 IN PLACE IDENTIFIED BY STAKEHOLDERS.".
- 10 Page 4, strike lines 8 through 21 and substitute:
 - 11 "(b) AT A MINIMUM, THE STAKEHOLDERS CONSULTED WITH
12 PURSUANT TO SUBSECTION (2)(a) OF THIS SECTION MUST INCLUDE
13 REPRESENTATIVES FROM COMMUNITIES THAT HAVE EXISTING RESOURCES
14 AND PROGRAMS; COMPREHENSIVE COMMUNITY BEHAVIORAL HEALTH
15 PROVIDERS; ESSENTIAL BEHAVIORAL HEALTH SAFETY NET PROVIDERS
16 THAT FURNISH CRISIS SERVICES; REPRESENTATIVES FROM LOCAL
17 PROGRAMS RELEVANT TO THE COMMUNITY, SUCH AS FAMILY RESOURCE
18 CENTERS, DOMESTIC VIOLENCE PROGRAMS, SUBSTANCE USE TREATMENT
19 PROVIDERS, AND INDEPENDENT CLINICIANS OR QUALIFIED UNLICENSED
20 INDEPENDENT PROVIDERS; REPRESENTATIVES CERTIFIED IN PEDIATRIC
21 HEALTH CARE; REPRESENTATIVES FROM AGENCIES PROVIDING LAW
22 ENFORCEMENT AND FIRE PROTECTION; REPRESENTATIVES FROM AN
23 ORGANIZATION REPRESENTING EMERGENCY MEDICAL SERVICES,
24 EMERGENCY RESPONSE SERVICES, OR THE STATE EMERGENCY MEDICAL
25 AND TRAUMA SERVICES ADVISORY COUNCIL CREATED IN SECTION
26 25-3.5-104; AND ANY OTHER REPRESENTATIVES THE DEPARTMENT AND
27 BEHAVIORAL HEALTH ADMINISTRATION DETERMINE ARE NECESSARY.".
- 28 Page 4, strike lines 22 and 23.
- 29 Page 4, line 24, strike "CONVENING THE STAKEHOLDER GROUP" and
30 substitute "CONSULTING WITH THE STAKEHOLDERS".
- 31 Page 4, lines 25 and 26, strike "DECEMBER 31, 2025," and substitute
32 "JUNE 30, 2026,".

- 1 Page 4, line 27, strike "ANALYZE" and substitute "REPORT".
- 2 Page 5, line 1, after "GAPS" insert "IDENTIFIED BY THE STAKEHOLDERS".
- 3 Page 5, line 2, after "DEPARTMENT" insert "AND THE BEHAVIORAL HEALTH
- 4 ADMINISTRATION".
- 5 Page 5, line 5, strike "2026" and substitute "2027".
- 6 Page 6, line 27, strike "IN ACCORDANCE WITH" and substitute "A
- 7 HOSPITAL THAT IS SUBJECT TO".
- 8 Page 7, lines 1 and 2, strike "ACT, 42 U.S.C. SEC. 1395DD, A FACILITY"
- 9 and substitute "ACT", 42 U.S.C. SEC. 1395dd,".
- 10 Page 7, line 4, strike "FACILITY" and substitute "HOSPITAL".
- 11 Page 7, line 5, strike "FACILITY IF THE FACILITY" and substitute "HOSPITAL
- 12 IF THE HOSPITAL".
- 13 Page 7, line 6, after "MEDICAL" insert "OR BEHAVIORAL HEALTH".
- 14 Page 7, strike lines 7 and 8 and substitute "AND THE RECEIVING HOSPITAL
- 15 AGREES TO THE TRANSFER.".
