

HOUSE COMMITTEE OF REFERENCE AMENDMENT  
Committee on Energy & Environment.

SB19-092 be amended as follows:

1 Amend reengrossed bill, page 2, lines 2 and 3 strike "**amend** (7)(b)(I)"  
2 and substitute "**add** (7)(c)".

3 Page 2, line 6, strike everything after "**screen**" and substitute "**program**  
4 - **repeal**. (7) (c) (I) THE DEPARTMENT OF PUBLIC HEALTH AND  
5 ENVIRONMENT SHALL SEEK APPROVAL FROM THE ENVIRONMENTAL  
6 PROTECTION AGENCY OF A PROPOSED REVISION TO THE SIP THAT WOULD  
7 ENABLE A VEHICLE THAT FAILS THE ON-BOARD DIAGNOSTICS TEST SOLELY  
8 BECAUSE A CHECK ENGINE LIGHT IS ILLUMINATED ON THE VEHICLE'S  
9 DASHBOARD TO TAKE A TAILPIPE EMISSIONS TEST. THE DEPARTMENT  
10 SHALL SUBMIT THE PROPOSED SIP REVISION TO THE COMMISSION BY  
11 SEPTEMBER 31, 2019, THE COMMISSION SHALL ADOPT THE PROPOSAL BY  
12 DECEMBER 1, 2019, AND THE DEPARTMENT SHALL SUBMIT THE PROPOSAL  
13 TO THE ENVIRONMENTAL PROTECTION AGENCY BY MAY 5, 2020. BEFORE  
14 SUBMITTING THE PROPOSAL TO THE COMMISSION, THE DEPARTMENT SHALL  
15 PROVIDE THE OPPORTUNITY FOR WRITTEN COMMENT AND SHALL HOLD A  
16 STAKEHOLDER MEETING TO SOLICIT INPUT ON THE PROPOSAL. THE  
17 PROPOSAL MUST TAKE INTO CONSIDERATION ANY STAKEHOLDER INPUT  
18 RECEIVED, INCLUDING FROM EMISSIONS INSPECTORS, OWNERS OF VEHICLES  
19 THAT FAILED THE ON-BOARD DIAGNOSTICS TEST SOLELY BECAUSE A CHECK  
20 ENGINE LIGHT WAS ILLUMINATED ON THE VEHICLES' DASHBOARD,  
21 LEGISLATORS, MOTOR VEHICLE MANUFACTURERS, AND AIR QUALITY  
22 CONTROL EXPERTS.

23 (II) THIS SUBSECTION (7)(c) WILL BE REPEALED IF THE  
24 ENVIRONMENTAL PROTECTION AGENCY REJECTS THE PROPOSED SIP  
25 REVISION. THE DIRECTOR OF THE DIVISION SHALL NOTIFY THE REVISOR OF  
26 STATUTES IN WRITING OF THE DATE ON WHICH THE CONDITION SPECIFIED  
27 IN THIS (7)(c)(II) HAS OCCURRED BY E-MAILING THE NOTICE TO  
28 REVISOROFSTATUTES.GA@STATE.CO.US. THIS SUBSECTION (7)(c) IS  
29 REPEALED, EFFECTIVE UPON THE DATE IDENTIFIED IN THE NOTICE THAT  
30 THE CONDITION OCCURRED OR, IF THE NOTICE DOES NOT SPECIFY THAT  
31 DATE, UPON THE DATE OF THE NOTICE TO THE REVISOR OF STATUTES.".

32 Page 2, strike lines 7 through 18.
