**A BILL FOR AN ACT**

101     **CONCERNING TRANSFERS FROM THE ECONOMIC RECOVERY AND**  
102         **RELIEF CASH FUND TO PROVIDE ADDITIONAL FUNDING FOR THE**  
103         **MANAGEMENT OF CERTAIN NATURAL RESOURCES, AND, IN**  
104         **CONNECTION THEREWITH, MAKING AN APPROPRIATION.**

The bill requires the state treasurer to make the following transfers from the economic recovery and relief cash fund:

- \$3 million to the healthy forests and vibrant communities

fund for projects that will help communities address the urgent need to reduce wildfire risks by supporting implementation of risk mitigation treatments that focus on promoting watershed resilience;

- \$2 million to the wildfire mitigation capacity development fund for wildfire mitigation and fuel reduction projects;
- \$10 million to the Colorado water conservation board construction fund for watershed restoration and flood mitigation grants;
- \$2.5 million to the Colorado water conservation board construction fund for the direct and indirect costs of providing assistance to political subdivisions and other entities applying for federal "Infrastructure Investment and Jobs Act" money and other federally available money related to water funding opportunities; and
- \$2.5 million to the Colorado water conservation board construction fund for issuing grants to political subdivisions of the state for the hiring of temporary employees, contractors, or both that will assist those political subdivisions and other entities in applying for federal "Infrastructure Investment and Jobs Act" money and other federally available money related to natural resource management.

All of these transfers relate to essential government services and must comply with the relevant compliance, reporting, record-keeping, and program evaluation requirements established by the office of state planning and budgeting and the state controller.

2           **SECTION 1.** In Colorado Revised Statutes, 24-75-228, **add** (2.5)

3       as follows:

4           **24-75-228. Economic recovery and relief cash fund - creation**

5       **- allowable uses - interim task force - report - legislative declaration**

6       **- definitions - repeal.** (2.5) (a) UPON THE EFFECTIVE DATE OF THIS

7       SUBSECTION (2.5), OR AS SOON AS POSSIBLE THEREAFTER, THE STATE

8       TREASURER SHALL TRANSFER TWENTY MILLION DOLLARS FROM THE

9       ECONOMIC RECOVERY AND RELIEF CASH FUND AS FOLLOWS:

10       (I) THREE MILLION DOLLARS TO THE HEALTHY FORESTS AND

1 VIBRANT COMMUNITIES FUND CREATED IN SECTION 23-31-313 (10), WHICH  
2 MUST BE EXPENDED FOR THE PURPOSES SPECIFIED IN SECTION 23-31-313  
3 (6)(a)(IV);

4 (II) TWO MILLION DOLLARS TO THE WILDFIRE MITIGATION  
5 CAPACITY DEVELOPMENT FUND CREATED IN SECTION 24-33-117 (1),  
6 WHICH MUST BE EXPENDED FOR THE PURPOSES SPECIFIED IN SECTION  
7 24-33-117 (3);

8 (III) TEN MILLION DOLLARS TO THE COLORADO WATER  
9 CONSERVATION BOARD CONSTRUCTION FUND CREATED IN SECTION  
10 37-60-121 (1)(a), WHICH MUST BE EXPENDED FOR THE PURPOSES SPECIFIED  
11 IN SECTION 37-60-121 (12);

12 (IV) TWO MILLION FIVE HUNDRED THOUSAND DOLLARS TO THE  
13 COLORADO WATER CONSERVATION BOARD CONSTRUCTION FUND CREATED  
14 IN SECTION 37-60-121 (1)(a), WHICH MUST BE EXPENDED FOR THE  
15 PURPOSES SPECIFIED IN SECTION 37-60-121 (13); AND

16 (V) TWO MILLION FIVE HUNDRED THOUSAND DOLLARS TO THE  
17 COLORADO WATER CONSERVATION BOARD CONSTRUCTION FUND CREATED  
18 IN SECTION 37-60-121 (1)(a), WHICH MUST BE EXPENDED FOR THE  
19 PURPOSES SPECIFIED IN SECTION 37-60-121 (14).

20 (b) THE WATERSHED RESTORATION PROGRAMS, WILDFIRE  
21 MITIGATION PROGRAMS, AND THE PROVISION OF SERVICES TO ASSIST  
22 POLITICAL SUBDIVISIONS OF THE STATE AND OTHER ENTITIES IN THE DRAW  
23 DOWN OF FEDERAL FUNDS TO WHICH THE STATE TREASURER SHALL  
24 TRANSFER MONEY FROM THE FUND PURSUANT TO SUBSECTION (2.5)(a) OF  
25 THIS SECTION ARE ESSENTIAL GOVERNMENT SERVICES.

26 (c) ANY DEPARTMENT THAT RECEIVES MONEY FROM THE  
27 TRANSFER MADE BY THE STATE TREASURER PURSUANT TO SUBSECTION

1 (2.5)(a) OF THIS SECTION SHALL COMPLY WITH THE COMPLIANCE,  
2 REPORTING, RECORD-KEEPING, AND PROGRAM EVALUATION  
3 REQUIREMENTS ESTABLISHED BY THE OFFICE OF STATE PLANNING AND  
4 BUDGETING AND THE STATE CONTROLLER IN ACCORDANCE WITH SECTION  
5 24-75-226 (5).

6 **SECTION 2.** In Colorado Revised Statutes, 37-60-121, **add** (12),  
7 (13), and (14) as follows:

8 **37-60-121. Colorado water conservation board construction**  
9 **fund - creation - nature of fund - funds for investigations -**  
10 **contributions - use for augmenting the general fund - funds created**  
11 **- rules - repeal.** (12) (a) EXCEPT AS SPECIFIED IN SUBSECTION (12)(b) OF  
12 THIS SECTION, THE BOARD SHALL USE THE MONEY TRANSFERRED  
13 PURSUANT TO SECTION 24-75-228 (2.5)(a)(III) FOR WATERSHED  
14 RESTORATION AND FLOOD MITIGATION GRANTS TO RESTORE, MITIGATE,  
15 AND PROTECT STREAM CHANNELS AND RIPARIAN AREAS SUSCEPTIBLE TO  
16 FLOOD HAZARDS AND SEDIMENT EROSION AND DEPOSITION AFTER  
17 WILDFIRE, INCLUDING EXPENDITURES FOR THE DESIGN AND  
18 IMPLEMENTATION OF PROJECTS INTENDED TO MITIGATE INCREASED FLOWS,  
19 SEDIMENT, AND DEBRIS, WITH FEDERAL AND LOCAL MATCHING  
20 REQUIREMENTS.

21 (b) THE BOARD MAY USE UP TO FIVE PERCENT OF THE MONEY TO  
22 ADMINISTER THE GRANT PROGRAM AS SPECIFIED IN SUBSECTION (12)(a) OF  
23 THIS SECTION AND MAY USE UP TO TEN PERCENT FOR THE COSTS  
24 ASSOCIATED WITH PROVIDING NECESSARY TECHNICAL ENGINEERING  
25 SERVICES TO ASSIST GRANTEES WITH DESIGN REVIEW, ENGINEERING  
26 ANALYSIS, FIRE AND FLOOD SUPPORT, CONSTRUCTION OVERSIGHT, FLUVIAL  
27 HAZARD ZONE PROGRAM IMPLEMENTATION, PROJECT MONITORING AND

1 ADAPTIVE MANAGEMENT, AND OVERALL PROGRAM MANAGEMENT.

2 (c) THE DEPARTMENT OF NATURAL RESOURCES SHALL INCLUDE  
3 UPDATES REGARDING THE BOARD'S ACTIVITIES UNDERTAKEN PURSUANT  
4 TO THIS SUBSECTION (12) IN ITS DEPARTMENTAL PRESENTATION TO  
5 LEGISLATIVE COMMITTEES OF REFERENCE PURSUANT TO SECTION 2-7-203.

6 (d) THIS SUBSECTION (12) IS REPEALED, EFFECTIVE JULY 1, 2027.

7 (13) THE BOARD SHALL USE THE MONEY TRANSFERRED PURSUANT  
8 TO SECTION 24-75-228 (2.5)(a)(IV) FOR THE DIRECT AND INDIRECT COSTS  
9 OF PROVIDING ASSISTANCE TO POLITICAL SUBDIVISIONS OF THE STATE AND  
10 OTHER ENTITIES IN APPLYING FOR FEDERAL "INFRASTRUCTURE  
11 INVESTMENT AND JOBS ACT", PUB.L. 117-58, MONEY AND OTHER  
12 FEDERALLY AVAILABLE MONEY RELATED TO WATER FUNDING  
13 OPPORTUNITIES.

14 (14) (a) THE BOARD SHALL USE THE MONEY TRANSFERRED  
15 PURSUANT TO SECTION 24-75-228 (2.5)(a)(V) FOR BOTH:

16 (I) ISSUING GRANTS TO POLITICAL SUBDIVISIONS OF THE STATE OR  
17 OTHER ENTITIES FOR THE HIRING OF TERM-LIMITED EMPLOYEES,  
18 CONTRACTORS, OR BOTH THAT WILL ASSIST THOSE POLITICAL  
19 SUBDIVISIONS AND OTHER ENTITIES IN APPLYING FOR FEDERAL  
20 "INFRASTRUCTURE INVESTMENT AND JOBS ACT", PUB.L. 117-58, MONEY  
21 AND OTHER FEDERALLY AVAILABLE MONEY RELATED TO NATURAL  
22 RESOURCE MANAGEMENT; AND

23 (II) COVERING THE DIRECT AND INDIRECT COSTS ASSOCIATED WITH  
24 ISSUING THE GRANTS DESCRIBED IN SUBSECTION (14)(a)(I) OF THIS  
25 SECTION.

26 (b) THE BOARD MAY ADOPT POLICIES AND PROCEDURES AS  
27 NECESSARY FOR IMPLEMENTING A GRANT PROGRAM NECESSARY TO

1 AWARD THE GRANTS DESCRIBED IN SUBSECTION (14)(a) OF THIS SECTION.

2 **SECTION 3. Appropriation.** For the 2022-23 state fiscal year,  
3 \$15,000,000 is appropriated to the department of natural resources for use  
4 by the Colorado water conservation board. This appropriation is from the  
5 Colorado water conservation board construction fund created in section  
6 37-60-121 (1)(a), C.R.S. To implement this act, the board may use this  
7 appropriation for watershed restoration and flood mitigation project  
8 grants. Any money appropriated in this section not expended prior to July  
9 1, 2023, is further appropriated to the board from July 1, 2023, through  
10 December 30, 2024, for the same purpose.

11 **SECTION 4. Safety clause.** The general assembly hereby finds,  
12 determines, and declares that this act is necessary for the immediate  
13 preservation of the public peace, health, or safety.
