1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, 24-34-104, **repeal**
3 (15)(a)(I); and **add** (30) as follows:

4 **24-34-104. General assembly review of regulatory agencies**
5 **and functions for repeal, continuation, or reestablishment - legislative**
6 **declaration - repeal.** (15) (a) The following agencies, functions, or both,
7 will repeal on September 1, 2018:

8 (I) ~~The automobile theft prevention authority and the automobile~~
9 ~~theft prevention board created in section 42-5-112, C.R.S.;~~

10 (30) (a) THE FOLLOWING AGENCIES, FUNCTIONS, OR BOTH, ARE
11 SCHEDULED FOR REPEAL ON SEPTEMBER 1, 2029:

12 (I) THE AUTOMOBILE THEFT PREVENTION AUTHORITY AND THE
13 AUTOMOBILE THEFT PREVENTION BOARD CREATED IN SECTION 42-5-112.

14 (b) THIS SUBSECTION (30) IS REPEALED, EFFECTIVE SEPTEMBER 1,
15 2031.

16 **SECTION 2.** In Colorado Revised Statutes, 42-5-112, **amend**
17 (6)(a) as follows:

18 **42-5-112. Automobile theft prevention authority - board -**
19 **creation - duties - rules - fund - repeal.** (6) (a) This section is repealed,
20 effective September 1, ~~2018~~ 2029.

21 **SECTION 3. Act subject to petition - effective date.** This act
22 takes effect at 12:01 a.m. on the day following the expiration of the
23 ninety-day period after final adjournment of the general assembly (August
24 8, 2018, if adjournment sine die is on May 9, 2018); except that, if a
25 referendum petition is filed pursuant to section 1 (3) of article V of the
26 state constitution against this act or an item, section, or part of this act

1 within such period, then the act, item, section, or part will not take effect
2 unless approved by the people at the general election to be held in
3 November 2018 and, in such case, will take effect on the date of the
4 official declaration of the vote thereon by the governor.
