A BILL FOR AN ACT

101 **CONCERNING ORGANIZATIONAL REQUIREMENTS TO QUALIFY**
102 **APPLICANTS TO BE ISSUED THE COLORADO PROFESSIONAL FIRE**
103 **FIGHTERS LICENSE PLATE.**

Bill Summary

(Note: This summary applies to this bill as introduced and does not reflect any amendments that may be subsequently adopted. Current law provides for the issuance of a Colorado professional fire fighters license plate and sets standards for organizations that may qualify applicants to be issued the license plate. One of the qualifications is that the organization has been in existence for at least 20 years. The bill lowers this requirement to at least 15 years.

Current law also requires that the organization have at least 3,000 members residing in Colorado. The bill specifies the evidence an organization is to submit to demonstrate compliance with this provision.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, 42-3-254, **amend**
3 (3)(a)(II); and **add** (3)(d) as follows:

4 **42-3-254. Special plates - Colorado professional fire fighters**
5 - **definition.** (3) (a) At least once every five years, the department shall
6 designate an organization to qualify applicants to be issued the Colorado
7 professional fire fighters license plate. The organization must:

8 (II) Have been in existence for at least ~~twenty~~ FIFTEEN years;

9 (d) A SIGNED AFFIDAVIT, SUBMITTED UNDER PENALTY OF PERJURY,
10 IS SUFFICIENT EVIDENCE THAT THE ORGANIZATION HAS MET THE MINIMUM
11 MEMBERSHIP AS REQUIRED IN SUBSECTION (3)(a)(III) OF THIS SECTION.

12 **SECTION 2. Act subject to petition - effective date.** This act
13 takes effect at 12:01 a.m. on the day following the expiration of the
14 ninety-day period after final adjournment of the general assembly; except
15 that, if a referendum petition is filed pursuant to section 1 (3) of article V
16 of the state constitution against this act or an item, section, or part of this
17 act within such period, then the act, item, section, or part will not take
18 effect unless approved by the people at the general election to be held in
19 November 2022 and, in such case, will take effect on the date of the
20 official declaration of the vote thereon by the governor.
