The bill makes school psychologists eligible for a stipend program for nationally certified school professionals, and makes other clarifications to the stipend program statute. The bill increases state workload beginning in FY 2019-20.

## Summary of Legislation

Under current law, the Colorado Department of Education awards \$1,600 stipends to teachers or principals who hold a certification from the National Board for Professional Teaching Standards (NBPTS), and an additional \$3,200 (for a total of \$4,800) to NBPTS-certified teachers or principals working in a low-performing, high-needs school.

The bill adds school psychologists who hold a certification from the National Association of School Psychologists and meet the other program requirements to list of eligible school professionals who qualify for the stipends. The bill also corrects the name of NBPTS and clarifies that school counselors who hold a certification from the National Board for Certified Counselors are eligible for the program, in order to align with current practice.

## Background

For the 2017-18 school year, 529 educators received the \$1,600 stipend and 54 educators received the \$4,800 stipend, for a total of approximately \$1.1 million distributed.

## **State Expenditures**

The bill increases the workload for CDE to administer the stipend program for certified school psychologists beginning in FY 2019-20. The workload impact is expected to be about \$3,125 and 0.1 FTE, with staff in the Educator Talent Division reviewing applications, verifying eligibility with school districts and distributing the stipends. This workload increase can be accomplished within current appropriations.

In addition, adding additional eligible school professionals is likely to make the program more competitive. The program was appropriated \$1.4 million for FY 2018-19. If funding is not sufficient to cover all eligible school professionals, stipends must only be awarded to those candidates who are employed in a low-performing, high-needs school, at the higher stipend level.

## **School District Impact**

The bill increases the workload for school districts to receive the stipends from CDE and distribute them to eligible school psychologists. The increase is expected to be minimal and will vary by district.

## **Effective Date**

The bill was signed into law by the Governor on February 28, 2019, and takes effect August 2, 2019, assuming no referendum petition is filed.
