After consideration on the merits, the Committee recommends the following:

<u>HB18-1177</u> be amended as follows, and as so amended, be referred to the Committee of the Whole with favorable recommendation:

- 1 Amend the Public Health Care & Human Services Committee Report,
- 2 dated March 13, 2018, page 1, line 21, strike "THE OFFICE OF SUICIDE".
- 3 Page 1, strike lines 22 through 24.
- 4 Page 2, strike lines 1 through 3 and substitute "THE OFFICE OF".
- 5 Page 2, strike lines 7 through 11.
- 6 Renumber succeeding subparagraph accordingly.

Page 2, line 19, after "PROGRAMS." add "STARTING OCTOBER 1, 2018,
AND AT LEAST QUARTERLY THEREAFTER, THE DEPARTMENT SHALL POST
ON ITS WEBSITE A SCHEDULE OF TRAINING CLASSES OR PROGRAMS
OFFERED BY THE CONTRACTED NONPROFIT ORGANIZATION.".

11 Page 4, strike lines 8 through 20 and substitute:

"(V) FOR THE FISCAL YEAR COMMENCING JULY 1, 2018, THE
GENERAL ASSEMBLY SHALL APPROPRIATE TWENTY-FIVE THOUSAND
DOLLARS TO THE OFFICE OF SUICIDE PREVENTION FOR THE CREATION AND
DEVELOPMENT OF A WEBSITE TO SERVE AS A CLEARINGHOUSE FOR ACCESS
TO PREEXISTING MENTAL HEALTH RESOURCES AVAILABLE THROUGHOUT
COLORADO. THE OFFICE SHALL CONSULT WITH THE COLORADO YOUTH
ADVISORY COUNCIL, CREATED PURSUANT TO SECTION 2-2-1302, AND THE

YOUTH SUICIDE PREVENTION WORKGROUP OF THE SUICIDE PREVENTION
 COMMISSION ON THE DEVELOPMENT OF THE WEBSITE AND, WHEN

 COMPILED BY THE COUNCIL AND WORKGROUP. THE WEBSITE MUST BE
 YOUTH FRIENDLY, CULTURALLY SENSITIVE, AND AVAILABLE IN BOTH
 ENGLISH AND SPANISH.".

7 Page 6, after line 28 insert:

8 "SECTION 6. Appropriation. (1) For the 2018-19 state fiscal 9 year, \$375,000 is appropriated to the department of human services for 10 use by the office of behavioral health. This appropriation is from the 11 general fund. To implement this act, the office may use this appropriation 12 for the behavioral health crisis response system telephone hotline.

(2) For the 2018-19 state fiscal year, \$97,838 is appropriated to
the department of public health and environment for use by the prevention
services division. This appropriation is from the general fund and is based
on an assumption that the division will require an additional 0.3 FTE. To
implement this act, the division may use this appropriation for suicide
prevention "
