15 HISTORICAL SOCIETY SHALL SHARE WITH THE DEPARTMENT ALL  
16 NECESSARY INFORMATION ABOUT THE TAX CREDIT CREATED BY THIS  
17 SECTION TO ENABLE THE HISTORICAL SOCIETY AND THE DEPARTMENT TO  
18 PROPERLY ADMINISTER THE TAX CREDIT.".

23 2016, and on a quarterly basis thereafter,".
- 24 Page 27, strike lines 1 and 2 and substitute "the office shall provide a  
25 report to the department specifying the ownership and transfers of tax  
26 credits FOR THE REHABILITATION OF QUALIFIED COMMERCIAL STRUCTURES  
27 under this section COVERING THE PERIOD SINCE THE LAST REPORT.".
- 28 Page 27, line 3, strike "shall" and substitute "~~shall~~ MAY".

- 1 Page 27, strike line 15 and substitute "except that section 39-22-514.5
- 2 (5.5)(a)(III) and (8)(c)(IV)(A), Colorado Revised Statutes, as enacted".
